The learned P.O. submit that, the Respondent has communicated that, in case of the post of P.S.I. a special G.R. is there, which would show that, the upper age limit for the recruitment to the post of P.S.I. is 31 years for "Open" category, and therefore, the general G.R. relied in by the applicant dated 25.4. 2016 would not be applicable. It was also pointed out that, the applicant was of 32 years of age on the cutoff date.

3. Learned P.O. further submit that, the copy of the G.R. would be secured within few days. In the circumstances, at the request of learned P.O., S.O. to 6.3.2017.
