2. Learned Advocate for the applicant has submitted that the applicant has been promoted as Block Development Officer on 07.07.2016 and posted in the office of Panchayat Samiti, Shrirampur, Dist. Ahmednagar from the post of Assistant Block Development Officer, Panchayat Samiti, Kopergaon, Dist. Ahmednagar. He has submitted that the applicant has not completed his normal tenure of posting on the present post. He has submitted that the applicant is due for retirement on 31.05.2019 and he made request to make his transfer in other Talukas of Ahmednagar district by submitting an application. But his request has not considered by the respondents and he has been transferred by the impugned order dated 30.07.2018 and posted to Dharmabad, District Nanded, which is out of Nashik Division. He has submitted that the impugned transfer order is against the provisions of the Maharashtra Government

Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005 (in short "the Transfer Act 2005"). He has submitted that the applicant is not yet relieved and therefore, he prayed to grant stay to the operation and execution of the impugned order of transfer.

3. Learned C.P.O. has submitted that the applicant is serving in Ahmednagar district since the year 2004 and on his request he has been transferred. He has submitted that the impugned order has been issued in view of Section 4(4) and 4(5) of the Transfer Act 2005 on account of administration and there is no illegality in it. Therefore, he prayed to reject the interim relief as prayed by the applicant. He has further submitted that he has to take instructions from the respondents as to whether the applicant has been relieved or not and also requires time to file detailed affidavit in reply of the respondents.

4. Considering the facts in the present case, it is crystal clear that the applicant made a request to transfer him in other Talukas of Ahmednagar district, but he has been transferred to Dharmabad, Dist.
