Heard Shri Avinash S. Deshmukh, learned Advocate for the applicant and Shri M.S. Mahajan, learned Chief Presenting Officer for respondents.

2. The applicant has challenged the impugned order dated 31.05.2017, by which he has been transferred from Ahmedpur, Dist. Latur to Laakh, Tq. Aundha Nagnath, Dist. Hingoli. It is the contention of the applicant that his daughter is studying in 12th Std. and other two sons studding in 8th Std. at Latur. It is his further contention that he has requested to transfer him at Latur, but his request has not been considered by the respondents and he has been transferred to Hingoli district. It is his contention that he has been relieved from the presenting posting by the order dated 27.09.2017 w.e.f. 30.9.2017. It is contention of the applicant that nobody has been

posted on his present posting at Ahmedpur and therefore, he prayed to stay the execution of impugned order and requested to repost him at Ahmedpur.

3. Learned Chief Presenting Officer has submitted that the applicant has already been relieved w.e.f. 30.09.2017. He has submitted that the applicant was due for transfer and therefore, he has been transferred from Ahmdpur to Laakh, Tq. Aundha Nagnath, Dist. Hingoli. He has submitted that since the applicant has completed his normal tenure in the Latur district, he has been transferred by impugned order and therefore, there is no illegality in the impugned order of transfer. Therefore, he prayed to reject the interim relief as claimed by the applicant. He has submitted that the respondents have to file detailed affidavit and therefore, he seeks time to file affidavit.

4. Considering the documents on record, it reveals that the applicant has been transferred from Ahmedpur, Dist. Latur to Laakh, Tq.

Aundha Nagnath, Dist. Hingoli by impugned order dated 31.05.2017, since he has completed his normal tenure of posting in Latur district. The applicant made representation thereafter, but his representation has not been decided by the respondents. Since many officers like applicant have not joined duties on their new posting in view of the impugned transfer order, the respondent No. 2 issued order dated 27.09.2017 and relieved the applicant and others w.e.f. 30.09.2017. Since, the impugned order has been implemented and the applicant has been relieved, in my opinion, it is not a fit case to grant interim relief. Hence, the request of the applicant for grant of interim relief is hereby rejected.

5. Issue notices to the respondents, returnable on 08.11.2017.

6. Tribunal may take the case for final disposal at this stage and separate notice for final disposal shall not be issued.

7. Applicant is authorized and directed to serve on respondents intimation/notice of date of hearing duly authenticated by Registry, along

with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

8. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

9. The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date. Applicant is directed to file affidavit of compliance and notice.
