2. On perusal of record, it reveals that the applicant has been transferred from Chalisgaon to Pohare, Tq. Chalisgaon by order dated 15-05-2018 issued by Sub Divisional Officer, Chalisgaon. Thereafter, S.D.O. modified the order to the extent of the applicant and transferred him to Mehunbare by order dated 31-05-2018. Thereafter, Tahsildar, Chalisgaon issued relieving order dated 31-05-2018 and directed the applicant to join new posting at Mehunbare. Accordingly, applicant joined new posting at Mehunbare on 05-06-2018 and submitted report.

3. S.D.O. Chalisgaon passed another order dated 31-05-2018 and modified the posting of the

applicant and he has been retained at Chalisgaon and posted respondent no.3 at Mehunbare. On perusal of record, it reveals that on the same day i.e. on 31-05-2018 two modified orders having outward no.292 and 301 were issued by S.D.O., Chalisgaon regarding transfer of the applicant.

4. Prima facie, it seems that the earlier order dated 31-05-2018 bearing outward no.292 has been executed though another modified order has been issued on the same day bearing outward no.301 cancelling the transfer of the applicant.

5. Learned Advocate for the applicant has submitted that the impugned order dated 31-05-2018 having outward no.301 has been issued subsequently and it has been served on the applicant on 06-06-2018 and now the respondents are compelling him to join on the modified posting. Therefore, he prayed to grant stay to the execution of the said impugned order.

6. Learned P.O. has submitted that both the modified orders are issued on very day i.e. on 31-05-2018. In fact, Tahsildar ought to have implemented the subsequent order bearing outward no.301 instead of earlier modified order having outward no.292. He has submitted that there is no illegality in the order, and therefore, he prayed to reject the interim relief.

7. On perusal of record it reveals that earlier modified order bearing outward no.292 by which the applicant has been posted at Mehunbare has been implemented and the applicant has joined the new posting. In these circumstances, it is just to stay the execution and operation of the impugned order dated 31-05-2018 bearing outward no.301 till filing of the reply by the respondents. Accordingly, impugned order is stayed till filing of the reply by the respondents.

Shri Jadhav, learned Advocate for res. no. 3 submits that in pursuance of the order dtd. 27.4.2018 he issued notice to res. no. 3 to remain present and file affidavit in reply as directed by the Tribunal. However, a envelope containing notice sent by him was returned by the postal authority as the said res. no. 3 is not residing on the said address. He files on record the said postal envelope along with office copy of notice. The said documents are taken on record and marked as document 'X collectively'.

3. In view of above, it appears that the affidavit in reply of res. no. 3 could not be filed. Hence, Shri Jadhav, learned Advocate for res. no. 3, on his request, is discharged from the present case.

4. In the circumstances, S.O. to 12.7.2018 for final hearing in absence of reply of res. no. 3 on the line of order dtd. 17.4.2018.
