4. Learned CPO has submitted that respondents want to file detailed reply, therefore, he sought time. He has submitted that as on today respondent no.3 has not joined new posting and applicant has not been relieve from his present posting.

5. On going through the documents on record, it reveals that the applicant has been transferred as Executive Engineer, National Highway Division, Aurangabad in the month of May, 2017. He has not completed his normal tenure of posting. He has not been transferred elsewhere till today but the respondent no.1 issued impugned transfer order dated 17-07-2018 posting respondent no.3 at his place by modifying earlier posting order of respondent no.3 dated 27-06-2018.
