2. Shri Anant Devakate learned Advocate for the applicant in M.A. has prayed to review/recall the order dated 20-08-2019 passed by this Tribunal in O.A.No.732/2019 on the ground that the applicant Sudhir Thombre has been transferred and posted as Deputy Chief Executive Officer, General Administration, Zilla Parishad, Nanded. Accordingly, he has been relieved from the post of Block Development Officer, Aundha Nagnath, Dist. Hingoli on 19-08-2019. He has submitted that applicant in

M.A. has given joining report to Chief Executive Officer, Zilla Parishad, Nanded on 19-08-2019. Meanwhile, applicant Rajendra Tubakale filed this O.A. and obtained interim protection. He has submitted that because of interim protection granted to Shri Rajendra Tubakale the applicant could not able to join his new posting. He has submitted that the applicant Rajendra is not a selection Grade BDO, and therefore, he cannot be retained on the post of Deputy CEO, General Administration, Zilla Parishad, Nanded, which is an earmarked post for Selection Grade BDO. He has submitted that since the present applicant Sudhir Thombre has been relieved and not permitted to join the posting because of the interim protection given to the applicant, he is in the hanging position. Therefore, inconvenience is caused to the applicant and accordingly he has prayed to recall the interim order and vacate the interim protection granted to the applicant in O.A.

3. Learned P.O. has submitted that the issue regarding transfer of the original applicant Rajendra Tubakale is under consideration and his transfer order

will be issued in near future. He has submitted that the post of Deputy CEO Administration, Zilla Parishad, Nanded is an earmarked post and only Selection Grade BDO or Deputy CEO can be appointed on the said post.

4. Shri A.S.Deshmukh learned Advocate has submitted that the original applicant Rajendra is serving as Deputy CEO, General Administration, Zilla Parishad, Nanded since June, 2017. The respondents issued the impugned transfer order without making transfer of the applicant Rajendra. He has submitted that without any transfer order, the applicant cannot be shifted or relieved. Therefore, this Tribunal has granted interim protection to the applicant. He has submitted that there is no just ground for recalling the order. Therefore, he has prayed to reject the present M.A.

5. On going through the record, prima facie, it reveals that the post of Deputy CEO, General Administration, Zilla Parishad, Nanded is an earmarked post for appointment of Deputy CEO or

Selection Grade BDO. There is no dispute about the fact that the original applicant Rajendra Tubakale is not a Selection Grade BDO but he has been posted on the said post in June, 2017. No doubt, the competent authority is empowered to make transfer of the applicant from the said post on administrative ground and to appoint the eligible selection grade BDO or Deputy CEO on the said post but the respondent has to follow the procedure as contemplated under the Transfer Act, 2005. Without following the provisions of the Transfer Act and without making transfer of the original applicant, respondent competent authority has issued the impugned order and transferred the applicant in M.A. on the post. Two officers cannot be posted on the single post. In these circumstances, considering the fact that the original applicant Rajendra Tubakale has not been transferred from the post of Deputy CEO, Zilla Parishad, Nanded. This Tribunal has granted interim protection to the applicant Rajendra Tubakale. There is no just ground to recall the said order.
