- iv) On receiving such representation, if filed by the applicants, respondent No.2 viz. the Superintendent of Police, Jalna, shall give an opportunity to

the applicants of being heard and then take appropriate decision, as may be considered fit in the circumstances, on such representation within a further period of four weeks from the date of receipt of the representation.

- v) The decision taken shall be communicated to the applicants in writing by Registered post and till reply of such communication by the applicants, the amount claimed in the impugned order dated 17/18.12.2015 shall not be recovered from the applicants.
- vi) In the facts and circumstances of the case, there shall be no order as to costs.

3. In MA No.227/2017 the learned P.O. Shri N. U. Yadav placed on record a communication, which was received and the same was marked as "X". It is a common contention that, present applicants were called in the matter and thereafter the communication marked as "X" was sent by Registered post to the applicants. Vide said communication the representation of the present applicants were not accepted.
