2. The learned Advocate for the applicant has submitted that the respondents have not granted the provisional pension to the applicant in spite of the directions given by this Tribunal on 31.7.2017. He has submitted that in response to the said directions, the respondents filed affidavit in reply and stated that the regular pension has been sanctioned to the applicant, but it has not been disbursed because certain amount has to be recovered from the applicant and unless said amount is deposited by the applicant, the regular pension cannot be released to the applicant.

3. The learned P.O. submits that total amount of Rs. 13,25,449/- has to be recovered from the

applicant towards excess payment made to him on account of wrong fixation of pay. He has submitted that amount of Rs. 11,46,211/- has already been recovered from the applicant and amount of Rs. 1,79,238/- is yet to be recovered from the applicant. He has submitted that on depositing the said outstanding amount by the applicant, the pension will be released.

4. On perusal of the record it reveals that on 31.7.2017 this Tribunal has directed the respondents to take immediate steps for grant of provisional pension to the applicant, subject to the decision in the present application regarding recovery, if any. In response to the said directions, the res. No. 3 the Executive Engineer, Jalgaon Irrigation Division, Jalgaon filed affidavit in reply and stated that as the recovery amount has to be recovered from the applicant, the regular pension granted to him cannot be released.

5. On going through the affidavit in reply of Shri Rajendra Sitaram Visave, Executive

Engineer, Jalgaon Irrigation Division, Jalgaon, it reveals that, regular pension has been sanctioned to the applicant on 29.9.2016, copy of which is placed on record.

6. In view of the above facts, it is material on the part of the respondents to follow the directions given by this Tribunal dated 31.7.2017 and release the regular pension, subject to decision of the Tribunal in the present O.A. regarding recovery. Therefore, the res. No. 3 is directed to take immediate steps in that regard in view of the direction given by the Tribunal on 31.7.2017. The respondent no. 3 shall comply the order and file compliance report on the next date.

The learned Advocate for the applicant submits that the respondent issued the impugned order dtd. 26.7.2017 and directed the applicant to deposit the amount of Rs. 12,04,100/- as it has been mentioned in the special audit conducted by the C.A. that there was illegality. He has submitted that the impugned order has been issued without giving any opportunity of hearing to the applicant and therefore prayed to stay the impugned order dated 26.7.2017.

3. The learned C.P.O. has submitted that on receiving the impugned order dated 26.7.2017, the applicant has sought 1 ½ month's time for giving his explanation, but he has not filed any reply in that regard. He has submitted that there is irregularity in spending of huge amount of Rs. 14,00,348/- in the Madhuban Krushtadham Vasahat, where the applicant was serving as a Medical Officer. He has submitted that audit of

the affairs of the said institution has been made for the financial year 2011-12 to 2013-14 and the concerned C.A. noted the said irregularity and directed to recover amount of Rs. 12,04,100/- from the applicant, who was serving as a Medical Officer there at the relevant time. He seeks time to file detailed affidavit in reply by taking necessary instructions from the respondents.

4. On perusal of the record, it reveals that the impugned order is dated 26.7.2017 directing the applicant to deposit an amount of Rs. 12,04,100/- immediately as it has been noted during the special audit conducted by the C.A. that there was total irregularity in the expenditure of amount of Rs. 14,00,380/-. On perusal of record, it reveals that, no opportunity of hearing was given to the applicant before issuing the impugned order dtd. 26.7.2017. The principles of natural justice has not been followed while passing the said notice / order.

5. In the circumstances, it is just and proper to stay the execution of the impugned notice dated 26.7.2017 till next date. Hence impugned order dtd. 26.7.2017 is stayed till next date.

6. Issue notices to the respondents, returnable on 5.10.2017.

7. Tribunal may take the case for final disposal at this stage and separate notice for final disposal shall not be issued.

8. Applicant is authorized and directed to serve on respondents intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of O.A. Respondent is put to notice that the case would be taken up for final disposal at the stage of admission hearing.

9. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the question such as limitation and alternate remedy are kept open.
