Suman Mohan Jadhav has been recorded in the waiting list of eligible

candidates for the appointment on compassionate ground on 20.05.2006. He has submitted that the name of applicant has been enrolled by the respondents on his application on 09.06.2009. He has submitted that the applicant has not received employment till today and therefore, he prayed to issue directions to the respondents accordingly.

4. Learned Presenting Officer has submitted that already name of the applicant has been enrolled in the waiting list of the eligible candidates for the appointment on compassionate ground and therefore, there is no question to issue such direction to the respondents arises. Therefore, he prayed to reject the present Original Application.

5. I have gone through the documents on record. Page No. 39 of the paper book shows that after death of Shri Mohan Shankar Jadhav the name of his widow i.e. Suman Mohan Jadhav has been enrolled at Sr. No. 22 in the waiting list of eligible candidates for appointment on

compassionate ground maintained by the respondent No. 4 on 22.05.2005. Not only this, but thereafter the name of the applicant i.e. Durgesh Mohan Jadhav has been recorded in the waiting list at the same Sr. No. on 09.06.2009. Already respondent No. 4 has considered the application of the applicant and recorded the name of the applicant in the waiting list. Therefore, no question to consider the application of the applicant in that regard arises. The appointment order in favour of the applicant can be issued as per his turn and the seniority mentioned in the waiting list of the candidates who are to be appointed. Therefore, such directions as prayed for cannot be issued. There is no merit in the present Original Application. Consequently, it deserves to be dismissed.

6. In view of the above discussions in foregoing paragraphs, the O.A. stands dismissed. There shall be no order as to costs.
