2. This is an application filed by the respondents for extension of four months' time from 30/07/2016 to comply with the order passed by this Tribunal in O.A No. 950/2012 dated 30.4.2016.

3. It seems that the present Miscellaneous Application No. 403/2016 has been filed by the respondent State on 7.10.2016.

4. The learned Presenting Officer submits that the State Government has filed Writ Petition No. 12796 of 2016 before the Hon'ble Bombay High Court Bench at Aurangabad against the order passed by this Tribunal in O.A. No. 950/2012 dated 30.4.2016. He has also placed on record a copy of order dated 18<sup>th</sup> January, 2017 and the same is taken on record and marked as document 'X' for identification purpose.
