2. The Original Application is filed challenging the impugned order dated 19/22-07-2021 (Annex. 'A-5') passed by the Respondent No.3 re-fixing revised pay of the Applicant and thereby holding that excess amount paid to the Applicant in view of the earlier wrong pay fixation is to be recovered. The Applicant is seeking interim relief in terms of prayer clause E as follows:-

(E) Pending hearing and final disposal of the original application, the impugned order dtd.19/22.07.2021 issued by the respondent no.3 may kindly be stayed and the respondent no.3 kindly be directed not to recover the excess payments from the pension and /or from the amount of Commutation Value of pension of the applicant.

3. The Applicant retired from the post of Assistant Police Sub-Inspector w.e.f. 28.02.2021 vide order dated 05.02.2021 (Annex. 'A-1'). The Applicant is granted pension and pensionary benefits as per PPO dated 22.04.2021 (Annex. 'A-2').

4. Learned Advocate for the Applicant submits that the Applicant is group 'C' employee. The recovery of excess amount is ordered vide order dated 19/22-07-2021 (Annex. 'A-5') on account of wrong pay fixation and not on account of any misrepresentation made by Applicant. In view of the same, he says that the Applicant is entitled for stay to the impugned order of recovery in view of the decision of the Hon'ble Apex Court in the matter of **State of Punjab and others etc. V/s. RafiqMasih (White Washer) etc. in Civil Appeal No.11527 of 2014** dtd.18.12.2014 In paragraph 12 of the said judgment, it has been observed by Hon'ble the Apex Court as under:

"12. It is not possible to postulate all situations of hardship, which would govern employees on the issue of recovery, where payments have mistakenly been made by the employer, in excess of their entitlement. Be that as it may, based on the decisions referred to herein above, we may, as a ready reference, summarize the following few situations, wherein recoveries by the employers, would be impermissible in law:

- (i) Recovery from employees belonging to Class-III and Class-IV service (or Group 'C' and Group 'D' service).
- (ii) Recovery from retired employees, or employees who are due to retire

within one year, of the order of recovery.

- (iii) Recovery from the employees when the excess payment has been made for a period in excess of five years, before the order of recovery is issued.
- (iv)Recovery in cases where an employee has wrongfully been required to discharge duties of a higher post and has been paid accordingly, though even he should have rightfully been required to work against an inferior post.
- (v) *In any other case, where the Court* arrives at the conclusion, that recovery if made from the employees, would be iniquitous or harsh or arbitrary to such an extent, as would far outweigh the equitable balance of the employer's right to recover."

5. Learned P.O. for the Respondents on the other hand submits that after verification for pay scale of the Applicant by Pay Verification Unit pay of the applicant is revised and it is found that the Applicant was paid excess amount due to wrong pay fixation earlier. He seeks time for filing affidavit-in-reply.

6. On perusal of impugned order dated 19/22.07.2021 (Annex. 'A-5') it does not show that any show cause notice was given to the Applicant before fixation of revised pay. Moreover, the case of the Applicant falls within the parameter of judgment of Hon'ble Apex Court in the matter of **State of Punjab and others etc. V/s. RafiqMasih** (White Washer) etc. in Civil Appeal No.11527 of 2014 dtd.18.12.2014. Hence, in my opinion, it is fit case to grant interim relief as prayed by the Applicant.
