2. Learned Advocate for the applicant insisted for hearing of the present case on the point of interim relief. Hence, at the request and by consent of both the sides, this case is taken up for hearing on the point of interim relief.

3. Heard.

4. Learned Advocate for the applicant has submitted that Circular dated 17<sup>th</sup> May, 2015 has not been brought to his notice by the respondents, since he was on summer vacation during the period from 1<sup>st</sup> May, 2017 to 15<sup>th</sup> June, 2017. He has submitted that the Circular is not received to the school in which he was serving as a Secondary School Teacher and, therefore, he could not able to file the application within time in view of the aforesaid Circular dated 17<sup>th</sup> May, 2017. He

has submitted that as the Circular has not been received to the School in which he was serving, he has been deprived of appearing for the Departmental Competitive Examination-2017. Therefore, he prayed to issue directions to the respondents to accept his application form.

5. Learned Presenting Officer has submitted that already the date of filling up the application form is over and now the examination of the eligible candidates have been scheduled on 13<sup>th</sup> August, 2017. He has submitted that the applicant has not filled application form in time. Therefore, no interim relief can be granted in his favour.

6. On perusal of the documents placed on record, it reveals that the Circular dated 17<sup>th</sup> May, 2017 has been issued by the Government of Maharashtra inviting application forms from the eligible employees for the post of Deputy Education Officer and the examination has been scheduled on 13<sup>th</sup> August, 2017. The last date for filling up the application form was 6<sup>th</sup> June, 2017. In the said Circular, it was specifically mentioned that the said Circular has to be brought to the notice of the employees, who were on leave/

deputation. Even it is assumed that the applicant has been on vacation during the period from 1<sup>st</sup> May, 2017 to 15<sup>th</sup> June, 2017, it is the bounden duty of the applicant to collect information regarding Circular and file the application form for the post of Deputy Education Officer within time i.e. on or before 6<sup>th</sup> June, 2017. But he failed to submit the application form in time. Moreover, the recruitment process has reached at the stage of Examination which is scheduled on 13<sup>th</sup> August, 2017. The applicant has not approached the Tribunal at the earliest. Without filling up the application form for the post of Deputy Education Officer, the request of the applicant to grant interim relief cannot be considered at this advanced stage of recruitment. In these circumstances, in my opinion, it is not a fit case to exercise the discretion and grant interim relief.

7. In view of the above situation, the prayer made by the applicant for grant of interim relief is rejected.

8. Issue notices to the respondents, returnable on 8<sup>th</sup> September, 2017.

9. Tribunal may take the case for final disposal at this stage and separate notice for final disposal shall not be issued.

10. Applicant is authorized and directed to serve on Respondents intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of O.A.. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

11. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.
