2. The learned Advocate for the applicant has submitted that the applicant is working as a Dental Surgeon in the Sub District Hospital, Vaijapur, Tq. Vaijapur, Dist. Aurangabad since 1.1.2005 on ad-hoc basis. He has submitted that the res. no. 5 – The Medical Superintendent, Sub District Hospital, Vaijapur, Dist. Aurangabad has relieved the applicant on 7.9.2017 on the basis of telephonic instructions received to him from the res. no. 4 – The Civil Surgeon, Aurangabad and the res. no. 2 – The Director of Health Services, Mumbai - and accordingly the applicant has been relieved from the post of Dental Surgeon, Sub District Hospital, Vaijapur, Dist. Aurangabad. He has submitted that the res. no. 5 – The Medical Superintendent, Sub District Hospital, Vaijapur, Dist. Aurangabad has acted highhandedly and he has relieved the applicant by taking help of Police Authority. He has submitted that the applicant was not transferred by the respondents, but she

was directed to approach the Office of the Director of Health Services, Mumbai for getting further orders. He has submitted that the respondents have not followed the provisions of the Maharashtra Government Servants Regulation of Transfers & Prevention of Delay in Discharge of Official Duties Act, 2005 (in short Transfer Act, 2005) and they have illegally relieved the applicant. Therefore, he has prayed to grant interim stay to the impugned order dated 7.9.2017 issued by the res. no. 5.

3. The learned C.P.O. has submitted that the res. no. 5 has relieved the applicant in view of the instructions received to him from the res. no. 4 and res. no. 3 on telephone. He has submitted that the res. no. 5 has obeyed the telephonic directions given to him by his superior authorities. He has submitted that the applicant has refused to hand over the charge and therefore, the res. no. 5 has taken the help of the Police Authority. He has submitted that there are several complaints about the functioning and behavior of the applicant and, therefore, the higher authorities of res. no. 5 have decided to relieve the applicant from the post of Dental Surgeon, Sub District Hospital, Vaijapur, Tq. Vaijapur, Dist. Aurangabad. He has submitted that the respondents want to file detailed affidavit in reply in the matter and therefore, he sought

time. He has submitted that the applicant is already relieved on 7.9.2017 itself and therefore, there is no question to grant interim relief in favour of the applicant.

4. On going through the record, it reveals that the applicant was appointed on 1.1.2005 as a Dental Surgeon on ad-hoc basis and thereafter her services were continued. In view of the telephonic directions given by the res. nos. 2 & 4 on 6.9.2017, the res. no. 5 relieved the applicant on 7.9.2017. There is no any order in writing passed by the res. nos. 2 & 4 in the matter. The applicant has been abruptly relieved from the post on 7.9.2017 in view of the order issued by the res. no. 5.

5. In the circumstances, it is just to direct the res. nos. 2 & 4 to file their personal affidavits mentioning under which provisions they directed the res. no. 5 to relieve the applicant from the post of Dental Surgeon, Sub District Hospital, Vaijapur, Tq. Vaijapur, Dist. Aurangabad. The detailed affidavit in replies of the respondents is necessary to decide the matter on merit. Since the applicant has already been relieved from the post, it is not a fit case to grant interim stay to the execution of the impugned order dtd. 7.9.2017 issued by the res. no. 5. Hence, the

request of the applicant to grant interim relief is hereby rejected.

6. Issue notices to the respondents, returnable on 26.9.2017.

7. Tribunal may take the case for final disposal at this stage and separate notice for final disposal shall not be issued.

8. Applicant is authorized and directed to serve on respondents intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of O.A. Respondent is put to notice that the case would be taken up for final disposal at the stage of admission hearing.
