Heard Smt. U.A.Patil, learned counsel for the applicants (Original Respondents) and Miss A.Telange, learned counsel for the respondents (Original Applicant).

- 2. The applicants in this proceeding were respondents 2 and 3, and respondent no.2 herein (since deceased) was the applicant in O.A.No.608/2019. Legal heirs of the Original Applicant are brought on record.
- 3. Review of the Judgment and order dated 11.04.2023 is sought operative part of which reads as under –

# The O. A. is allowed in the following terms-

The applicant is held entitled to get pay scale of Junior Engineer on completion of 45 years of age as at this point of time he became entitled to get exemption from passing the departmental examination and had also completed service of 12 years. The benefits flowing from this determination shall be extended to the applicant within two months from today. Issue of interest is kept open.

4. On 31.05.2023 the Original applicant submitted application (Annexure-B) before applicant no.2 herein containing the following-

निकाल माझ्या बाजूने लागलेला असला तरी वर उल्लेखित केलेल्या दिनांकास

मला आश्वासित प्रगती योजनेचा द्सरा व तिसरा लाभ मंजूर केल्यास माझी

काहीही हकरत नाही व याबाबत मी संबंधित न्यायालयात दाद मागणार नाही.

तसेच दिनांक ११.०४.२०२३ रोजीच्या निकालाचे अनुषंगाने अवमान याचिका

दाखल करणार नाही.

5. Miss A.Telange, learned Advocate for legal heirs of the

original applicant submitted that in view of contents of the application

dated 31.05.2023, the R.A. be allowed as prayed. Case is made out to

review the order dated 11.04.2023. The order is reviewed and modified

as follows. Respondent no.2/Original Applicant is held entitled to

second benefit of time bound promotion w.e.f. 01.10.2006 and pay scale

of Junior Engineer w.e.f. 01.01.2016, and consequential benefits. The

R.A. is allowed in these terms with no order as to costs.
