2. We have perused Annexure A-1 i.e. the order of punishment. Punishment awarded was to deduct 5% of pension for a period of two years and the amount of deduction was Rs.14,330/- in three equal instalments. This order is dated 20.1.2016. The Ld. counsel for the applicant submitted that in fact this entire amount is recovered and the period of two years has expired and inspite of it, the department is paying him only provisional pension without assigning any reason. On perusal of the order, it seems that as the amount is already recovered and 5% of pension is already deducted for two years, therefore, there appears

no sound reason to stop the pension. It is submitted that even the provisional pension is not paid regularly to the applicant and pension used to be paid in *lump sum*. In view of this matter, it is suitable in the interest of justice to direct the respondents to pay the pension to the applicant as fixed by the Accountant General. The order be complied with within one month.
