2. It is grievance of the applicants that this Tribunal did not consider the material evidence and conclusion is drawn that there was no promotional avenue to the post of Helper. The learned counsel for the applicants submitted that as per the Judgment

delivered by the Full Bench of Hon'ble Bombay High Court in case of Chandrakant Sakharam Karkhanis & Ors. Vs. State of Maharashtra & Ors., 1977 (2) SLR, 142, the Circulars issued by the Government under Article 309 of the Constitution of India have a force of law. The learned counsel for the applicants invited our attention to Annex-A-2. The Annex-A-2 is the G.R. dated 08/10/1986. After reading this G.R., it is not possible to accept that any authority was given to the Director the respondents No.2 frame the service rules. Similarly, the learned counsel for the applicants was unable to point out any service rules approved by the Government, by which the applicants were entitled for the promotion on the post of Rigman. The learned counsel for the applicants also invited our attention to Page No.93. We have already examined this document which is at Annex-A-14. This document is signed by Shri A.D. Joshi, the then Deputy Engineer (Mechanical), Land Survey and Development Agency. After reading this document, we are unable to accept that this has anything to do with Article 309 of the Constitution of India. Our attention is also invited to the Circular Annex-A-15, dated 17/2/1994. In this Circular, at Sr.Nos.1 to 5 the posts are arranged in sequence of hierarchy. First Junior Engineer (Grade-III), then ; kf=dh] then I gk; d vkond] then fixeu and at the last enruhl - In this Circular it is nowhere mentioned that this was the promotional channel available to the Helper.

3. In view of this, we do not see any merit in the contention that without examination of the evidence, conclusion is drawn that the post of Rigman was not promotional post for the Helper. On the contrary, we will reiterate that in Para-11 of the

Judgment after considering the correspondence between the Deputy Director, GSDA, Aurangabad and Director, GSDA, Pune view was taken that the post of Rigman was not promotional post available to Helper and proposal was forwarded to the Head of the Department with a request to forward it to the Government for the approval. The learned counsel for the applicants accepted that till today no approval is given by the Governor to the said proposal, therefore, it is not possible for us to accept that without considering the evidence, conclusion is drawn that post of the Helper had no promotional avenue.

- 4. It is contention of the applicants that they were entitled for the benefit of the G.R. dated 15/4/1991. We have gone through Para-13 of the Judgment in which it is categorically mentioned that the Helpers were entitled for the benefit of this G.R. provided they were possessing the qualification to be appointed on the post of Clerk and they were in seniority eligible for the post. The learned counsel for the applicants was unable to point out that any Helper who was junior to them was appointed on the post of Clerk. We have already discussed this matter, therefore, it is not possible to accept that there is any error in the observations.
- 5. It is submitted by the learned counsel for the applicants that illegality is committed in fixing the pay of the applicants while giving benefit of time bound promotion. In this regard, we would like to point out that the post of the applicants had no promotional avenue, consequently, considering the G.R., pay of the applicants was

fixed as per the guidelines. It is contention of the applicants that as per 5th Pay Commission, they were eligible to claim the pay scale Rs.3200-85-4900/- and as per the 6th Pay Commission were eligible to the pay scale of Rs.5200-20200+G.P.Rs.2400/-. The learned P.O. has pointed out that the applicants are intending to claim the pay scale admissible to the post of Rigman, but as the post of the applicants i.e. Helper had no promotional avenue, therefore, while giving benefit of time bound promotion this pay

6. In view of this discussion, we do not see any merit in the application for Review. Hence, the application for Review stands rejected. No order as to costs.
