Heard Shri N.B. Rathod, Id. counsel for the applicants and Shri A.M. Ghogre, Id. P.O. for the State.

2. It appears that the Id. counsel for the applicants has not filed C.A. for Joint O.A. The Id. counsel for the applicants undertakes to file C.A. for Jt. Application by 16/3/2022. On this condition, the O.A. is heard. If the learned counsel for the applicants is not filed C.A. for Joint O.A., the notices will not be issued.

3. The learned counsel for the applicants submitted that in the present O.A. the applicants are in service. He also submitted that in similar matters i.e. O.A. 456/2022 with connected O.As. the M.A.T., Bench at Aurangabad has passed the order on 11/3/2022. The operative portion of the order dated 11/3/2022 is reproduced below –

*“(1) Issue notice to the respondents in all these matters, returnable on 7/4/2022.*

*(2). Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.*

*(3) Applicants are authorized and directed to serve on Respondent/s intimation / notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.*

*(4) This intimation / notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.*

(5) *The service may be done by Hand delivery, speed post, courier and acknowledgement be obtained and produced along with affidavit of compliance in the Registry before due date. Applicants are directed to file Affidavit of compliance and notice.*

**(6) *The M.P.S.C. is directed to provisionally accept the application forms of all these applicants in the present O.As.***

**(7) *The M.P.S.C. shall make alternate arrangement for accepting the application forms of all these applicants physically, in the event the online acceptance fails.***

**(8) *The learned C.P.O. is requested to communicate this order telephonically to the M.P.S.C."***

**4. The same relief is granted to the applicants in the present O.A.**

**S.O. four weeks.**

**MCA 22/2021 in O.A. 920/2020 -**

Heard Shri S.N. Gaikwad, Id .counsel for the applicant and Shri H.K. Pande, Id. P.O. for the respondents.

2. In the earlier order dated 9/7/2021 in para-2&4 following order was passed –

“2. The respondents have filed reply dated 14/6/2021 (P-30) and on page no.36 it is mentioned that the increment date of applicant is 1/6/2004. As per this, since the applicant retired on 30/6/2005, he must have been given increment on 1/6/2005. So after getting the increment he got only one month and retired on 30/6/2005. For working one month, he cannot claim for next increment as on 1/7/2005. In this situation, his claim of demanding increment of 1/7/2005 does not sustain. If he is denied next increment of 1/6/2005, the respondents should give due increment as on 1/6/2005 and then decide the retiral benefits.

4. In view of above discussion and as amended by the Id. counsel in relief clause, the increment due on 1/6/2005 be given to the applicant and consequent to that all retiral benefits be given to the applicant. The whole



exercise should be done within 90 days from the date of receipt of this order”.

3. However, the respondents have filed application on 18/8/2021 and it appears that even before passing of the order, the respondents have complied the order regarding grievance of the applicant.

4. In view of this, the MCA No.22/2021 is disposed off. No order as to costs.

**CA 72/2022 in O.A. 884/2020 -**

Heard Shri P.D. Meghe, Id. counsel for the applicant and Shri H.K. Pande, Id. P.O. for the respondents.

2. The Id. counsel for the applicant relied on Hon'ble Supreme Court in case of **Rakesh Kumar Vs. State of Bihar & Ors., 2022 (SC) 250** delivered on 18/2/2022 more particularly para-24 of the Judgment.

3. The learned P.O. has placed on record correspondence dated 7/1/2022 issued by District Dairy Development Officer, Gadchiroli wherein on second page in para-2 it is mentioned as follows –

4. In view of above, it appears that the respondents have called the applicant to submit the application for grant of leave period. However, the applicant is not co-operating.

5. In this situation, the learned counsel for the applicant is directed that he should ask the applicant to co-operate with the respondents / department and appear before the office and submit the leave application which were balance to him.

6. In the earlier order dated 6/9/2021 in para-3 it was mentioned as below –

“3. The learned counsel is directed to ask the applicant to submit leave application which were balance to him and the respondents are directed to sanction the leave of applicant between 23/3/2020 to 31/5/2020. If no leave is balance to the applicant, then the respondents are directed to sanction the leave period as without pay but to be considered for all other benefits including retiral/pensionary benefits. After sanctioning the leave, they should move other retiral benefits papers and ensure that the applicant get the retiral benefits at earliest.”

6. In view of above, the learned counsel is directed to ask the applicant to submit leave application which were balance to him and the respondents are directed to sanction the leave of applicant between 23/3/2020 to 31/5/2020. If no leave is balance to the applicant, then the respondents are directed to sanction the leave period as without pay but to be considered for all other benefits including retiral/pensionary benefits. After sanctioning the leave, they should move other retiral benefits papers and ensure that the applicant get the retiral benefits at earliest.

7. With this direction, the C.A. is disposed off.

The Id. counsel for the applicant submits that other retiral benefit of applicant is pending.
