- The Id. Counsel for the applicant has 2. out provisional pointed seniority list published by respondents dated 16/02/2019 (Annexure-A-7) of Class-IV employees. It appears that this seniority list for period as on 01/01/2019. Subsequently, respondents have list published final seniority as on 19/03/2019 (Annexure-A-8). In both these lists, the applicant was at Sr. No. 1. Since, the joining date of the applicant is 25/02/2010 and he fulfils all the criteria laid down by the Recruitment Rules, Gazette Notification, dated 06/06/2017 (Annexure-A-15). *Prima facie,* as per this list applicant is placed at right place in this seniority list.
- 3. However, respondents have again published the provisional seniority list as on 23/04/2019 (Annexure-A-10), as per date it appears that it is as on 01/01/2019. In this list, applicant has been placed on Sr. No. 21.

The Id. Counsel for the applicant also pointed out that applicant has raised objection by representation dated 24/04/2019 (Annexure-A-11) and he was asked for personal hearing as per letter dated 04/05/2019 (Annexure-A-12). However, applicant was not provided record about personal hearing. He again requested to provide details about the personal hearing vide representation dated 22/05/2019 (Annexure-A-13).

- 4. Meanwhile, respondents have issued order of promotion vide letter dated 27/05/2019 (Annexure-A-14), which is signed on 25/05/2019. As per the ld. Counsel for the applicant, 25/05/2019 was holiday and respondents rushed to published this order without finalizing provisional seniority list as published by them only vide letter dated 23.04.2019 (Annexure-A-10).
- 5. Prima facie, it appears that first of all respondents should have finalized provisional seniority list published as on 01/01/2019 vide their own letter dated 23/04/2019. But they failed to finalize the provisional seniority list and issued promotion order dated 27/05/2019 (Annexure-A-14).
- 5. In view of these facts and circumstances, issue notices to the

respondents returnable within three weeks from the date of this order. Meanwhile, respondents are directed that while issuing promotion order as per letter dated 27/05/2019 (Annexure-A-14), they must keep one post vacant till filing of the reply.

- 6. Issue notice to R-2 to 9, returnable on three weeks. Learned P.O. waives notice for R-1. Hamdast allowed.
- 7. Tribunal may take the case for final disposal at this stage and separate notice for final disposal shall not be issued.
- 8. Applicant is authorized and directed to serve on Respondents intimation / notice of date of hearing duly authenticated by Registry, along with complete paper book of O.A. Respondent is put to notice that the case would be taken up for final disposal at the stage of admission hearing.
- 9. This intimation / notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules,1988, and the questions such as

limitation and alternate remedy are kept open.

- 10. The service may be done by Hand delivery, speed post, courier and acknowledgement be obtained and produced along with affidavit of compliance in the Registry within one week. Applicant is directed to file Affidavit of compliance and notice.
- 11. In case notice is not collected within **three days** and if service report on affidavit is not filed **three days** before returnable date. Original Application shall stand dismissed without reference to Tribunal and papers be consigned to record.
