2. Applicant has filed present O.A. seeking following reliefs:

“A. This original application may kindly be allowed.

B. The order dated 29/09/2022 issued by Director, Health Services, Maharashtra State Mumbai thereby declaring the applicant non-eligible for admission to NEET PG-2022 PG Course may kindly be quashed and set aside.

C. The order/communication dated 04/10/2022 bearing Outward No.AAS/PGCell/DnP/Dr. Gangane/1481/2022 dated 04/10/2022 issued by the office of Director, Health Services, Maharashtra State Mumbai may kindly be quashed and set aside.

D. It be declared that, the applicant is eligible to be admitted to NEET PG – 2022 PG Course as per his merit and by adding the marks for the service given by the applicant in tribble and difficult area and accordingly respondents be directed to admit the applicant to NEET PG course as per the preference given by the as in-service candidate.

E. It be direct the respondent authority to accept the amount for the breach of bond and thereby consider the name of the petitioner as in-service candidate with the incentive marks of the service given by the petitioner in difficult and tribble area.

F. Any other appropriate orders may passed in interest of justice.

G. Cost of this application be awarded.”

3. Applicant has sought following interim relief:

“a. By an order of interim relief, the operation of the order dated 29/09/2022 and 4/10/2022 of the Director of Health Services declaring the applicant as not eligible for admission to PG Course be stayed and suspended.

b. By an order of interim relief, the Director Health Service be direct to add the name of the applicant as in-service candidate by adding the marks for the service given by the applicant in

tribe and difficult area for further round/ selection list.

c. By an order of interim relief, the Commissioner, State CET Cell Mumbai may kindly be directed to consider the candidature of the applicant for admission to the PG Course as per the preference and the his merit by adding the marks for the service given by the applicant in tribe and difficult area and to give admission to the applicant to the Post Graduate course.

d. Any other appropriate interim orders may be passed.

4. Shri Kakde, learned Counsel appearing for the applicant submitted that the request of the applicant to be considered as in-service candidate for completing the PG course has been rejected by the respondents for wrong reasons. Learned Counsel pointed out the order of rejection which is at page 287 of the paper book of O.A. Name of the applicant is at Sr.No.88. Applicant is declared to be not eligible and in the remarks column following remarks are entered:

“As per clause 9 of G.R. dated 19-03-2019 and clause 9.1 of G.R. dated 26-03-2020 not eligible as bond not completed also NOC not issued.”

5. On the aforesaid two grounds request of the applicant has been rejected. Learned Counsel submitted that the applicant had approached the Hon'ble High Court by filing Writ Petition No.10235/2022 seeking writ of mandamus or any other appropriate writ, order or directions in like nature, thereby directing the respondent authority to grant the permission to break the bond by depositing the amount to the authority and thereby consider the name of the petitioner as in-service candidate for P.G. Course. Said Writ Petition came to be disposed of by directing the respondent authorities, more particularly, respondent no.3 in the said Writ Petition to consider the application of the petitioner dated 26-09-2022 on its own merit and pass the appropriate order. Learned Counsel pointed out that the said authority decided application of the applicant and rejected the same mentioning therein that the applicant did not deposit the bond amount as provided in the G.R. dated 19-03-2019, more particularly, as per clause 9 of G.R. dated 19-03-2019 and clause 9.1 of G.R. dated 26-03-2020.

6. Learned Counsel submitted that in none of the said G.Rs. there is any such provision that the bond amount has to be deposited along with the form of application or at the time of seeking permission to appear for the entrance

examination. Learned Counsel in the circumstances, prayed for interim relief as reproduced hereinabove.

7. Learned Counsel further submitted that since the request of the applicant has not been considered, he has not been given any weightage of the service rendered by him in rural, remote or difficult areas. Learned Counsel submitted that, if at all, the Tribunal is inclined to grant interim relief as prayed for by the applicant, direction is required to be given to the respondent authorities to consider the said aspect also.

8. Request for interim relief made by the applicant has been opposed by the respondents. Learned P.O. though sought time for filing affidavit in reply further submitted that from the record also it appears that, the permission has been rejected on justifiable grounds. He invited my attention to clause 9 of G.R. dated 19-03-2019 and clause 9.1 of G.R. dated 26-03-2020. Learned P.O. submitted that having regard to the conditions as are incorporated in the said clauses, the application has been rightly rejected by the respondent authorities. Learned P.O. further invited my attention to clause 4.1 of the G.R. dated 19-03-2019. Learned P.O. submitted that the applicant was supposed to seek "No Objection" from the competent authority before

making an application for NEET PG Examination. Since the applicant did not make any such application before applying for the NEET PG Examination and submitted the same in the month of April, 2022, it has not considered. Learned P.O., therefore, submitted for rejecting the prayer for interim relief.

9. I have carefully considered the submissions advanced by the learned Counsel for the applicant as well as the learned P.O. In so far as the ground as about non-payment of bond amount is concerned, *prima facie* there appears no non-compliance, even in view of the clause 9 of G.R. dated 19-03-2019 and clause 9.1 of G.R. dated 26-03-2020. I deem it appropriate to reproduce hereinbelow both the said clauses, as those are in vernacular which read thus:

(Clause 9 of G.R. dated 19-03-2019)

“९. पदव्युत्तर अभ्यासक्रमासाठी निवड झालेल्या उमेदवारांनी पदव्युत्तर पदविका/पदवी अभ्यासक्रम पुर्ण झाल्यावर, असे वैद्यकीय अधिकारी सार्वजनिक आरोग्य विभागामध्ये (म्हणजेच सार्वजनिक आरोग्य विभागाच्या अखत्यारीतील आरोग्य संस्थांमध्येच) किमान ३ वर्षे सेवा व पदव्युत्तर पदवी पुर्ण झाल्यावर सार्वजनिक आरोग्य विभागाचे (म्हणजेच सार्वजनिक आरोग्य विभागाच्या अखत्यारीतील आरोग्य संस्थांमध्येच) किमान ५ वर्षे सेवा करतील असे बंधपत्र (हमीपत्र) अभ्यासक्रमासाठी रूजू होण्यापूर्वी संचालक, आरोग्य सेवा-१, मुंबई यांच्याकडे भरून देणे आवश्यक राहिल. बंधपत्रातील अटी न पाळल्यास सदर वैद्यकीय अधिका-यांना

रू.५०,००,०००/- (रू. पन्नास लक्ष) एवढी किंवा शासन वेळोवेळी विहित करेल एवढी बंधपत्राची रक्कम दंड म्हणून संचालक, आरोग्य सेवा-१, मुंबई यांचेकडे जमा करावी लागेल व असा दंड वसूल करावयाची जबाबदारी संचालक, आरोग्य सेवा-१, मुंबई यांची राहिल."

10. In none of the above G.Rs. it has been mandated that the bond amount has to be paid alongwith the application seeking permission to apply for PG Course as in-service candidate.

11. Vide application dated 26-09-2022, the applicant has requested the respondent authorities to accept the bond amount. However, that request was not considered and the applicant was required to approach the Hon'ble High Court. After the order was passed by the Hon'ble High

Court to consider the said application the concerned authority has rejected the application filed by the applicant referring to the clause 9 of G.R. dated 19-03-2019 and clause 9.1 of G.R. dated 26-03-2020.

12. It appears to me that the relevant provisions in aforesaid both the G.Rs. have not been properly interpreted by the respondents. *Prima facie*, therefore, it appears to me that the non-payment of bond amount at the time of making application for NEET PG Examination cannot be a reason for rejecting the candidature of the applicant for in-service candidate for PG Course.

13. The second reason assigned by the respondents is that, the applicant did not submit the application seeking No Objection for appearing in the NEET PG Examination before filing such application. It is true that, the applicant filled in application for NEET PG Examination 2022 in the month of February, 2022. It is further not in dispute that the applicant preferred an application seeking no objection to sit for the NEET PG Examination in the month of April, 2022.

14. As per clause 4.1 of the G.R. dated 19-03-2019 a candidate has to seek No Objection before making an application for the NEET PG Examination. However, the

respondent no.3 did not respond to the application filed by the applicant in the month of April, 2022 seeking No Objection for appearing in the NEET PG Examination. It was open for the said respondent to decide the application of the applicant submitted in the month of April, 2022 before the applicant appears for the said examination in May, 2022. There was no reply from the side of the respondents, the applicant appeared for the NEET PG Examination 2022 and secured 312 marks. As has been submitted by the learned Counsel for the applicant since the application preferred by the applicant on 02-04-2022 seeking permission to appear for NEET PG Examination was not rejected till the date of NEET PG Examination, the applicant presumed the said application to have been allowed and hence appeared for the NEET PG Examination.

15. Learned Counsel further pointed out that in the brochure of the NEET PG Examination also no such requirement is mandated that in-service candidate should obtain permission prior to making the application for the said examination. From the facts and circumstances which have come on record, it prima facie appears that the candidature of the applicant cannot be kept out of consideration on the aforesaid ground. However, the said aspect will certainly require adjudication at the time of final

hearing. Since the process for admission is in progress, I deem it appropriate to pass the following **ad-interim order**:

ORDER

(i) Issue notice to the respondents, returnable on 14-11-2022.

(ii) Respondents shall provisionally consider the candidature of the applicant as in-service candidate for PG Course by further considering the weightage, if any, liable to be given towards the service claimed to have been rendered by the applicant in rural, difficult or remote areas.

(iii) Respondents shall file their reply on or before 14-11-2022 on interim relief application and shall show cause *why this ad-interim order shall not be confirmed.*

(iv) Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

(v) This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

(vi) The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the

Registry before due date. Applicant is directed to file affidavit of compliance and notice.

(vi) S.O. to 14-11-2022.

(viii) Steno copy and Hamdast is allowed to both parties.

The learned C.P.O. further submitted that the applicant being contractual employee the respondents were not expected to conduct a regular

departmental enquiry. In the circumstances, the respondents have taken the decision not to continue the applicant further on the said post. The learned C.P.O. further submitted that the present is not the case that the applicant has been dismissed by way of punishment. He further submitted that in fact the appointment on the post on which the applicant was working has been already made and according to his information the concerned Medical Officer has joined on the said post.

5. According to the learned counsel for the applicant though another candidate was appointed on the post on which the applicant was working and though said candidate joined subsequently the said candidate resigned from the said post. The learned counsel in the circumstances prayed for restraining the respondents from filling the subject post.

6. After having considered the submissions advanced by the learned counsel appearing for the applicant and the learned C.P.O. for the respondents, it does not appear to me that it is possible to accept the request of the applicant to keep the subject post vacant. It would be against the public policy to keep the post of Medical Officer vacant. The issue involved in the present matter is whether the contractual employee possesses any right as the regular employee. Another question which requires adjudication is whether the stigma attached to the applicant without conducting enquiry can be sustained. These issues can be decided at the time of final hearing and till then the post of Medical Officer cannot be kept vacant. However, if ultimately the applicant succeeds necessary reliefs can be granted in favour of the applicant. In the

By this application the applicant is seeking condonation of delay of about 3 years, 2 months and 10 days caused in filing the accompanying Original Application under Section 19 of Administrative Tribunals Act, 1985 seeking revision in pension and arrears of pension.

2. The applicant stood retired on superannuation on 31.05.2017 from the post of Police Sub Inspector from the office of respondent No.1 i.e. the Superintendent of Police, Ahmednagar Dist. Ahmednagar. At the time of retirement the applicant was working on the post of P.S.I. and his pay was fixed in the pay scale of Rs.5200-20200 + Grade Pay of Rs.4300/-. This pay scale was granted in view of the promotion of the applicant to the post of Police Sub Inspector on 09.04.2012. However, after retirement,

the pension papers of the applicant were prepared of the post of Assistant Sub Inspector in the pay scale of Rs.5200-2022 + Grade Pay of Rs.2800/-. Thereby the applicant was put to loss in getting pension only because the applicant was temporarily promoted and that therefore he was not eligible for drawing the pension of the post of Police sub Inspector. In view of the same, the applicant is seeking revision in pension for which he is entitled. The applicant is not responsible for wrong pension fixation. The applicant was waiting that some positive steps would be taken by the respondents. The delay is not deliberate. Hence, this application.

Affidavit-in-reply is filed on behalf of the respondent No.1 by one Pranjali Navnath Sonavane working as Deputy Superintendent of Police, Ahmednagar, thereby it is contended that the Special Inspector General vide it's order dated 09.04.2012 gave posting of 30 non-qualified Assistant Sub-Inspector including the applicant under Rule 90(3) of Mumbai Police Act on the post of temporary P.S.I. Those temporary Police Sub-Inspectors were not continued

for more than period of 90 days from their appointment. Before completing 90 days, they were reverted to the post of Assistant Sub-Inspector. After one day gap they were re-appointed on the post of temporary Police Sub-Inspector. In view of the same, the applicant is not entitled for getting benefit of the pay scale of Police Sub-Inspector. There is no merit in the case of the applicant. The applicant was waiting that some positive steps would be taken by the respondents. The delay is not deliberate. Hence, this application.

3. By this application the applicant is seeking condonation of delay of about 1 year, 10 months and 5 days caused in filing the accompanying Original Application under Section 19 of Administrative Tribunals Act, 1985 seeking to challenge the impugned order/letter dated 22.12.2017 (Annex. 'D') issued by the respondent No.4 i.e. the Principal, Government I.T.I., Nanded Tq. & Dist. Nanded rejecting the claim of the applicant for compassionate appointment contending that compassionate appointment is available to the heirs of the deceased Government servant working in the Group 'C' or 'D', whereas the deceased father of the applicant was getting salary in the pay scale of Rs.9300-34800 + Grade Pay of Rs.4300 and seeking direction for his appointment on compassionate ground.

2. The applicant is son of the deceased Government servant named Ashok Gurunath Shete, who died in harness on 10.07.2010 while working with the respondent No.4 on the post of Maths Instructor. Thereafter immediately the applicant made application on 16.11.2010 (Annex. 'B') seeking compassionate appointment. The applicant persuaded his claim by making subsequent representations dated 24.09.2012 and 21.09.2017 (Annex. 'C' collectively). However, without considering the claim of the applicant, the respondent No.4 issued impugned order/letter dated 22.12.2017 (Annex. 'D') rejecting the claim of the applicant for compassionate appointment.

3. It is contended that the deceased father of the applicant was having unblemished service. The claim of the applicant is rejected contending that the deceased father of the applicant was getting pay in the pay scale of Rs.9300-34800 with Grade Pay of Rs.4300/- which is for Group 'B'. In fact the deceased father of the applicant remained throughout on the same post as Maths Instructor falling in Group 'C' category. The applicant has good case on merits as

regards classification of the post of deceased father of the applicant in view of the G.R. dated 02.07.2002 (Annex. 'E' collectively) governing the classification of post on the basis of pay scale. There is however delay in filing the Original Application. The delay is not deliberate. The applicant could not instruct his Advocate as he was suffering from High Blood Pressure and was undergoing medical treatment. Hence, this application.

4. In spite of grant of opportunities, affidavit-in-reply is not filed on behalf of the respondents.

5. I have heard at length the arguments advanced by Shri N.K. Tungar, learned Advocate for the applicant on one hand and Shri N.U. Yadav, learned Presenting Officer representing the respondents on other hand.

6. Considering the date of impugned order/letter dated 22.12.2017 (Annex. 'D') and filing of this Original Application on or about 17.12.2020, there is delay of about 1 year 10 months and 5 days in filing the Original Application. It is a fact that from 23.03.2020 onwards there was nation wise Lock-down

due to Covid-19 pandemic situation. The applicant is seeking condonation of delay also on the medical ground for which he has placed on record the medical papers which would show that in the year 2019, he was suffering from High Blood Pressure and was undergoing medical treatment. So far as the merit of the case is concerned, it is to be seen as to whether the post held by the deceased father of the applicant was falling under Group 'C' or 'B' category. That is crucial in order to consider the claim of the applicant for compassionate appointment.

7. In the circumstances, refusing to give indulgence is likely to defeat the cause of justice at the threshold. It is a settled principle of law that the expression "sufficient cause" is to be construed liberally. Thereby the applicant had nothing to gain. In view of the same, this is a fit case to condone the delay of about 1 year, 10 months and 5 caused in filing the Original Application by imposing moderate costs upon the applicant. I compute the costs of Rs.500/- (Five Hundred only) on the applicant and proceed to pass the following order: -

By this application the applicant is seeking condonation of delay of about 4 years and 02 days caused in filing the accompanying Original Application under Section 19 of Administrative Tribunals Act, 1985 challenging the impugned communication/letter dated 28.01.2015 (Annex. '28' of O.A.) issued by the respondent No.2 i.e. the Superintending Engineer & Administrator, Command Area Development Authority, Latur, thereby rejecting the claim of the applicant for compassionate appointment stating that there is no provision for substitution of the name in the policy of compassionate appointment.

2. The father of the applicant namely Gangadhar Prabhu Kamble while in Government service in the office of Executive Engineer Majalgaon Project Division, Majalgaon on the post of Senior Clerk died in harness

on 15.02.1995. The mother of the applicant made application for compassionate appointment on 31.03.1995. On 16.10.2001, the applicant's mother's name was recommended for compassionate appointment in the office of the respondent No.5 but the appointment letter was not issued to her. On completion of the age of 40 years, her name was deleted from the waiting list as per letter dated 15.07.2008. The applicant at that time was minor. He completed age of majority on 23.09.2011 and made application on 10.09.2013. His claim was rejected by the impugned communication stating that there is no provision for substitution of name in the scheme of compassionate appointment.

3. It is contended that there are various decisions of the Tribunal and Hon'ble High Court stating that restrictions of substitution of name of legal heirs is not correct and such condition which was in G.R. dated 20.05.2015 is deleted. In view of the same, the applicant has good case on merits. There is, however, delay in presenting the Original Application. It is the contention of the applicant that the applicant was not

knowing that restriction of not substituting the name of the legal heirs was declared illegal by the decision of the Hon'ble High Court and also by decisions of various Benches of this Tribunal allowing the substitution of the name of the legal heirs. He got knowledge about the same when he read such news published in news papers on 20.11.2021. Before that Covid-19 pandemic situation was also going on. Hence, this application.

4. Affidavit-in-reply is filed on behalf of the respondent Nos.2 & 3 by one Sachin Ishwar Shivange working as Executive Engineer in the office of Majalgaon Canal Division No.7, Gangakhed, Dist. Parbhani, thereby he denied adverse contentions raised in the application and specifically contended that the applicant has no case on merits in view of concerned G.R. The impugned communication is legal and proper. In sufficient cause is shown by the applicant for huge delay. Hence, the application is liable to be rejected.

5. I have heard at length the arguments advanced by Shri K.B. Jadhav, learned Advocate for the

applicant on one, Smt. Deepali S. Deshpande, learned Presenting Officer representing the respondent Nos.1,4,5 & 6 and Shri S.B. Mene, learned Advocate for the respondent Nos.2 & 3 on other hand.

6. The Original Application along with this delay condonation application is filed on 15.12.2021 challenging the impugned communication dated 28.01.2015 issued by the respondent No.2 rejecting the claim of the applicant for compassionate appointment stating that there is no provision of substitution of name of legal heirs in the policy of compassionate appointment. In view of the same, the delay is of about 5 years 10 months and not 4 years and 2 months. It appears that while calculating the said delay, the applicant has deducted the period of prevailing situation of Covid-19 pandemic situation since March, 2020 onwards for about one and half year.

7. Considering the facts of the case it appears that the applicant has good case on merits. The applicant and his family members are waiting for compassionate

appointment since 1995. Though the mother of the applicant was recommended for getting compassionate appointment, she did not get actual appointment. Moreover, there are various decisions of this Tribunal allowing the substitution of name of legal heir of deceased Government servant for compassionate appointment. In such circumstances, the case of the applicant is required to be considered. It is possible only after registration of the Original Application.

8. In the circumstances as above, refusing to condone delay is likely to defeat the cause of justice at the threshold. The delay caused in the matter cannot be said to be deliberate or intentional. Thereby the applicant had nothing to gain. It is a settled principle of law that the expression "sufficient cause" is to be construed liberally. In view of the same, this is a fit case to condone the delay of about 5 years and 10 months caused in filing the Original Application by imposing moderate costs upon the applicant. I compute the costs of Rs.1,500/- (One Thousand Five Hundred only) on the applicant and proceed to pass the following order: -
