2. The learned counsel for the applicant pointed out the letter dated 04/01/2022 issued by the Additional Principal Chief Conservator of Forest, Nagpur in which he has given directions to all the concerned to follow the Judgment of Hon'ble Apex Court in the case <u>of State of Punjab & Ors.</u> etc. Vs. Rafig Masih (White Washer).

3. The learned counsel has pointed out the objection raised by the Pay Verification Unit. He has also submitted that the respondents / authority may recover the excess amount paid to the applicant. The applicant retired on 30/04/2019. He was working as a Ranger Surveyor which is Class-III post. The learned counsel has pointed out the Judgment in case of <u>of State of Punjab</u> <u>& Ors. etc. Vs. Rafig Masih (White Washer)</u>, more particularly, para-12 which is reproduced as below –

"12. It is not possible to postulate all situations of hardship, which would govern employees on the issue of recovery, where payments have mistakenly been made by the employer, in excess of their entitlement. Be that as it may, based on the decisions referred to herein above, we may, as a ready reference, summarise the following few situations, wherein recoveries by the employers, would be impermissible in law:-

(i) Recovery from employees belonging to Class-III and Class-IV service (or Group 'C' and Group 'D' service).

(ii) Recovery from retired employees, or employees who are due to retire within one year, of the order of recovery.

(iii) Recovery from employees, when the excess payment has been made for a period in excess of five years, before the order of recovery is issued.

(iv) Recovery in cases where an employee has wrongfully been required to discharge duties of a higher post, and has been paid accordingly, even though he should have rightfully been required to work against an inferior post. (v) In any other case, where the Court arrives at the conclusion, that recovery if made from the employee, would be iniquitous or harsh or arbitrary to such an extent, as would far outweigh the equitable balance of the employer's right to recover."

4. Heard Shri S.A. Deo, Id. CPO for the State. He has submitted that if the undertaking is given, then the department is at liberty to recover the said amount in view of Judgment of Hon'ble Apex Court in the case of <u>Jagdeo Singh.</u> In this regard on the side of respondent / authority it is necessary to show as to whether there was any undertaking given by the applicant.

5. In view of above, the respondents are directed not to recover excess amount paid to the applicant till filing of reply.

 Issue notice to the respondents returnable <u>16/06/2022</u>. Learned C.P.O. waives notice for State. Hamdast allowed.

7. Tribunal may take the case for final disposal at this stage and separate notice for final disposal shall not be issued.

8. Applicant is authorized and directed to serve on Respondents intimation / notice of date of hearing duly authenticated by Registry, along with complete paper book of O.A. Respondent is put to notice that the case would be taken up for final disposal at the stage of admission hearing.

9. This intimation / notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

When the applicant is ready to go to Moharli, then there was no hurdle for him to join at Chandrapur which is 40 Kms early from Tadoba/ Moharli.

6. The learned counsel for the applicant submitted that the applicant will join at Chandrarpur, but direction be given to the respondents / authority to consider him for transfer at Rajura.

7. Looking to the submission, the O.A. is disposed off. The applicant shall join at the transferred place at Chandrapur within a period of one week. He may request to the Authority by submitting representation for transfer at Rajura. The respondents / authority are directed to consider the same, if the vacant post is available at Rajura in the coming general transfers of April / May, 2022. No order as to costs.
