2. Applicant was appointed as Junior Clerk on compassionate ground vide order dated 17.09.2012. The applicant joined in the office of Deputy Conservator of Forest, Pandharkawda on 17.09.2012.

3. As per Notification dated 05.12.1980 (A-3, P. 17) and as per Clause 4 (1) every Clerk/Accountant appointed after the appointed date shall be required to pass the examination within three chances and within four years from the date of his/ her appointment.

4. However, Clause 4(3)(c) mentions that **The Chief Conservator of Forest may in exceptional circumstances at his discretion allow one extra chance to refer or recommend to appear for the examination and may where necessary correspondingly extend the period of four years mentioned in sub rule (1) to that of five years.** Applicant was appointed on 17.09.2012 and as per notification dated 05.12.1980 clause 4 (1) was required to pass in three chances within four years. As per application of applicant dated 15.04.2021, mentioned on P. 29, Applicant has availed first chance on 27&28.12.2014 and remained absent due to an accident and he could not appear in the examination. Again applicant got second chance on 27&28.12.2015 that time also due to some problem in eyes he could not appeared. Applicant got third chance on 17&18.12.2016 and this time applicant appeared but cleared only one paper. Subsequently, applicant period in fourth chance on 11&12.12.2017 and passed examination.

5. Id. Counsel has filed many cases where exceptions have been granted under clause 4 (c) and candidates appeared in fourth chance.

6. Respondents have filed their reply on 18.11.2022 on PP. 58 to 62. In para no. 7 it is mentioned that Sandeep Dashrath Palshikar, A.S.Girhi, Vijendra Gopal Borikar, S.J.Chaudhari & Ashulkumar Narayan Pawar were considered for fourth opportunity and their request were granted for fourth opportunity but there is difference that all these employees had taken prior permission from competent authority and then appeared for fourth chance. However, applicant did not take prior permission of the examination held in 2017 but passed the examination.

7. Subsequently, applicant had made representations 01.06.2020, 06.04.2022, 14.03.2022 requesting to consider his case sympathetically as per Section 4(3)(c). However, by impugned order dated 02.03.2022 (A-2, P. 14) applicant request has been rejected. It is on record that C.F., Yavatmal (respondent no. 3) vide his letter dated 29.10.2021 (A-8, P. 42) has recommended the case of applicant to respondent no. 2 to consider it sympathetically. After examining whole issue and health ground of applicant rival submissions were heard and following order is pass:-

ORDER

- A. Respondent no. 2 is directed to consider the applicant's application dated 14.03.2022 under rule 4(3)(c) of notification dated 05.12.1980 sympathetically within three months from the date of this order.
- B. With the above direction, **O.A. is disposed of with no order as to costs.**
