The learned counsel has filed letter dated 24/10/2007 issued by the Additional Director General of Police (Administration), M.S., Mumbai in which it has been clearly mentioned that after suspension if simple punishment like **fine or strict censure**, then suspension period does not get justified or it becomes very difficult to justify.

- 5. However, as per Annex-A-4,P-12, the request of applicant for granting allowance has been rejected by the respondent no.2 which is impugned order and against the principle of natural justice and law quoted above. In fact, the respondent no.2 by his own orders on page nos.11&12 has taken contradictory stand. 2. The father of applicant no.1 was working as ASI with the respondent no.3, i.e., Superintendent of Police, Washim. He was admitted in Hospital for treatment in January,2017. He expired on 29/4/2017, Department however, passed order 27/4/2017 retiring him prematurely on the ground that "Not fit for Police duty". This order is annexed at Annex-A-4,P-17. In the reply filed by respondent nos.2 to 4 on page 47 of the reply it is mentioned that this order was received by bother of applicant no.1, i.e. Rupesh B. Tayade on 28/4/2017. O.A.No.1040/2016 fully covered the grievance of the applicant which are reproduced as follows -9) These Judgments laid down the principles that are required to be borne in mind in considering the claims of the dependants of the deceased Government for servant compassionate appointments. It needs hardly be stressed that the facts are bound to differ. In the present set of circumstances, the facts are such where the enquiry hereinabove indicated has got to be made for a decision with regard to the compassionate appointment which would be just and proper. It is again made clear that it will not be an enquiry behind the back of the applicant and his family and the enquiry will have to be associated and concluded within the time limit set by this order, for otherwise, it should not become a matter of endless wait for the applicant and his family. They are entitled to know their fate one way of the other sooner than later.

10) This Original Application is disposed of with direction to the respondent no.1 to enquire into the aspect set out in detail in the body hereof, bearing in mind the directions therein and conclude it within a period of eight weeks from today. After the said enquiry, the issue of compassionate appointment of the applicant be decided within four weeks and communicate its outcome within one week thereafter to the applicant..

- 3. The Tribunal order was passed on 10.12.2019 (Annexure-A-1, P.B., Pg. No. 8) and in para no. 2 following directions are given which is reproduced below:-

"The applicant was suspended vide order dated 19.09.2016 (A-1, P-15) and after the MAT, Nagpur Bench Judgment in O.A. No. 716/2016 decided on 19.07.2018, the applicant was reinstated as per the order dated 15.09.2018 (A-3, P-22), however, the applicant's suspension period is yet to be decided. The suspension period appears to be quite long and in the interest of justice the respondents must decide the applicant's representation dated 15.04.2019 within one month (10.01.2020) from the date of this order. If the respondents fail to decide the application within four weeks, the applicant's suspension period will be treated as duty period."

- 4. However, today Id. P.O. has filed reply on C.P.. It appears that respondents have decided representation by order dated 02.02.2021, as per the order it has been decided almost after one year. In view of this situation, there decision in para no. 2 regarding suspension period is illegal against the order. The Id. counsel for the applicant has also pointed out order of this Tribunal dated 10.12.2019 was never challenged in Hon'ble High Court and hence, this order has attained its finality. At the same time, respondents have not approached to this Tribunal for filing extension of time for deciding the O.A.
- 5. In view of this situation, decision of suspension period in para no. 2 of order dated 02.02.2021 becomes illegal and it does not sustain in the eyes of law. The suspension period of applicant should be treated as per order dated 10.12.2019; as it has been observed that if the respondents have failed to decide the application within four weeks, the applicant's suspension period will be treated as duty period.
