2. We have seen that as per order dated 16.06.2022, Revenue Secretary has decided the representation half heartedly. It seems that it has not been decided in letter and spirit as pointed out by this Tribunal in its order dated 16.06.2022 related to Divisional Commissioner's Nagpur letter dated 20.09.2016 (A-5, Pg. No. 33). Probably, Revenue Secretary has missed the last two paragraphs of letter dated 20.09.2016 of Divisional Commissioner, Nagpur and it has not been considered while deciding the representation and in last but one para, Commissioner has clearly mentioned case of Shri Suryakant Yeole Government order dated 28.02.2013 (A-9, Pg. No.42) which is at par with applicant and applicant has submitted undertaking to Government. As Government G.A.D. G.R., पत्र क्रमांक - सी.डी.ई-२०१२/प्र.क्र.४४८/ई-९, dated 21.07.2016 while promoting Shri Suryakant Yeole and Circular of G.A.D. dated 02.04.1996 provides that during enquiry; the undertaking can be taken while giving promotional post. On this condition he will be promoted. This was also mentioned in Tribunal's order dated 16.06.2022.

3. By record it appears that the applicant has submitted the undertaking as per circular dated 02.04.1976 and G.R. dated 22.04.1996 (Pg. Nos. 19 & 20 of C.P.). There appears to be discrimination in case of applicant and case of Shri Yeole who was given promotion vide order dated 28.02.2013 and also promotion was given to Shri N.D.Gangurde by order dated 26.04.2021.

4. Hence, Respondent no. 1 is reminded that conscious decision that means it must be based on logic and it should be treated on the same line for justice and it should be treated for all similarly placed employee and all should be treated in the same manner.

5. Respondent no. 1 is also invited to see the circular issued by Chief Secretary of Maharashtra dated 28.02.2017 from Law and Judiciary Department regarding adherence to General Judicial Principle in service matters. It is accepted that direction issued by Chief Secretary from Law and Judiciary Department is binding on all the departments of Government of Maharashtra.

6. In view of above observations, Respondent no. 1 should decide the issue as par with Shri Suyakant Yeole and Shri N.D.Gangurde. He is further directed to go through the Judgment of Principal Bench in O.A. No. 470/2020 decided on 17.12.2020. Matter is adjourned today for two weeks, **S.O. two weeks for filing full compliance of order of the Tribunal dated 16.06.2022.**
