2. The ld. Counsel for the applicant submits that the applicant has not been relieved. He further submits that the applicant was transferred on 02.01.2023 from Sanglud to Pethetabarpur, Tah. Daryapur, Dist. Amravati. Applicant joined his services on 04.01.2023. Thereafter applicant had obstructed one tractor which was carrying the illegal sand. The Tahsildar Daryapur on 29.05.2023 directed him to lodge a complaint about the tractor which was carrying illegal sand and also threatened him. Instead of protecting the applicant, S.D.O., Daryapur has transferred him from Pethetabarpur to Yewada. It appears that transfer is pre-mature. From the impugned transfer order it appears that there was complaint against the applicant. Previous transfer order was also on complaint but nothing is on record.

3. Ld. C.P.O. submits that both the transfers are on complaint basis and, therefore, it cannot be said illegal.

4. There is no dispute that the impugned transfer order dated 26.06.2023 is pre-mature transfer. As per, The Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005 (In short "Transfers Act, 2005") it is illegal. If there was any complaint against the applicant the respondents should have taken necessary action. The respondents are at liberty to take necessary action against the applicant. The letter dated 29.05.2023 of Tahsildar, Daryapur shows that applicant was directed to lodge complaint against the person who threatened him.

4. The ld. Counsel for the applicant pointed out the judgement of **Hon'ble Supreme Court in the case of Arvind Dattatraya Dhande Vs. State of Maharashtra & Ors. (1997) 6 SCC 169. It is held that:-**

In view of the unimpeachable and eloquent testimony of the performance of the duties, it will be obvious that the transfer is not in public interest but is a case of victimisation of a honest officer at the behest of the aggrieved complainants carrying on the business in liquor and toddy. Under these circumstances, as stated earlier, the transfer of the appellant is nothing but malafide exercise of the power to demoralise honest officers who would efficiently discharge the duties of a public office.

5. From the perusal of record it appears that transfer is malafide hence liable to be stayed. Hence, **The impugned transfer order is stayed till the filing of the reply.**
