3. Learned counsel submits that the applicant has worked in the tribal / Naxalite area for about 9 years. He has pointed out Page no.26. The first posting of the applicant was at Deori, District Gondia. He was there from 26.11.2001 to 10.02.2003. His third posting was at Sadak Arjuni, District Gondia from 01.06.2007 to 13.07.2009. His next posting was at Gadchiroli from 13.07.2009 to 30.06.2013. Deori, Sadakarjuni and Gadchiroli are the Naxalite Tribal areas as notified by the State Government.

4. Learned counsel has pointed out the Judgment of Hon'ble Bombay High Court, Bench at Nagpur in W.P.No.2770/2013 decided on 17.01.2014 in which it is held that "employees, who have put in more than three years service in Tribal /Naxalite areas, are transferred out of said areas those employees who have put in three years service earlier in such areas, cannot be sent back to that areas." The applicant had worked in the Naxalite areas for about 9 years. Since he worked at Gadchiroli from 13.07.2009 to 30.06.2013 now by the impugned/ deputation order dated 15/7/2022, he is again posted at Gadchiroli.

5. Learned counsel has submitted that the applicant is yet not relieved. Looking to the submission and in view of the Judgment of Hon'ble Bombay High Court, Bench at Nagpur in Writ Petition No.2770/2013, the impugned order on deputation of the applicant is stayed till the filing of reply.
