4. I have gone through the reply, no cogent reason has been mentioned to by-pass the provision of Government order 1 (ii) dated 09.07.2019 regarding suspension position. The Id. counsel for the applicant has relied upon State Government of Maharashtra, G.R. dated 09.07.2019 (Annexure-A-5, P.B., Pg. No. 27) which covers various Judgments passed by Hon'ble Apex Court which are reproduced below:-

*"The Hon'ble Apex Court Judgment in **Ajay Kumar Choudhary Vs. Union of India through its Secretary & Ano., (2015) (2) SCALE** delivered on 16/02/2015 in C.A.1912 of 2015 (arising out of*

SLP (C) No.31761 of 2013). In para no.14 it is mentioned that suspension order should not extend beyond three months if within this period the Memorandum of charges / charge sheet is not served on the delinquent officer / employees; if the Memorandum of charges / charge sheet is served a reasoned order must be passed for the extension of the suspension.

In para 23, following observations are made:-*

23. This Court in Ajay Kumar Choudhary v. Union of India, (2015) 7 SCC 291 has frowned upon the practice of protracted suspension and held that suspension must necessarily be for a short duration. On the basis of the material on record, we are convinced that no useful purpose would be served by continuing the first Respondent under suspension any longer and that his reinstatement would not be a threat to a fair trial. We reiterate the observation of the High Court that the Appellant State has the liberty to appoint the first Respondent in a non sensitive post."

5. In view of this situation, suspension order dated 16.06.2020 (Annexure-A-3, P.B., Pg. No. 22) does not sustain in the eyes of law. Hence, the said order is required to be quashed and set aside.

O R D E R

1. The suspension order dated 16.06.2020 (Annexure-A-3, P.B., Pg. No. 22) is quashed and set aside.
2. Respondents are directed to reinstate the applicant in the service with immediate effect and treat the suspension period as duty period.
3. With the above directions, O.A. is disposed of with no order as to costs.
