2 The applicant is working P.S.I. being promoted as on temporary Ad-hoc basis vide order dated 7-11-2015 (A-4,P-46) for a period of two months extended thereafter and now according to the learned counsel for the applicant the period of appointment is till 2-9-2016 only. He seeks continuation on the post.

According to the learned 3. P.O., the 45 vacancies were available in the Buldhana district for promotion. In all, 66 persons have applied and the applicant's name in the seniority list is at Sr. No. 51. Consequently, his name was not recommended by the Special IGP, Amravati (R/5) for Ad-hoc The learned P.O. appointment. submits that the Superintendent of Police, Buldhana (R/3) has issued the order of applicant which is not proper, legal and valid and therefore the applicant cannot be continued.

4. At this stage, it does not assume significance whether the S.P., Buldhana was competent or not to issue order. Any how fact remains that the applicant is working on that post. The learned counsel

for the applicant submits that in W.P.Nos.8843/2014, 10877/2014 and 8919/2014 relying on statement of the Spl. Counsel appearing for respondent/state, the Hon'ble High Court has continued the temporary ad-hoc posts subject to the further orders passed by the Court. The above order is passed in the said W.Ps. and several applicants had approached before the Hon'ble High Court. In the case in hand, only one applicant is there. As such, the applicant be continued till other likely situated employees are continued on temporary ad-hoc basis as P.S.I.
