IUDGMENT

Heard Miss N.S.Pathan, learned counsel for the applicant, Shri H.K.Pande, learned P.O. for the Respondents 1 & 4 and Shri T.M.Zaheer, ld. Counsel for the respondents 2 & 3.

- 2. The applicant's mother was working as a Clerk with respondent no.3. She died while she was in service. The applicant applied for the appointment on compassionate ground. His application is not considered. Therefore, the applicant approached to this Tribunal for direction to the respondents to appoint him on compassionate ground.
- 3. The O.A. is strongly opposed by the respondents. It is submitted that the applicant is not entitled for appointment on compassionate ground because before the applicant, one Varsha applied for appointment on compassionate ground. Varsha is not a real daughter of deceased employee. Therefore, her name was not entered in the waiting seniority list for appointment on compassionate ground.
- 4. During the course of submission, learned counsel for the applicant has submitted that after attaining the age of majority the

applicant had applied first on 05.02.2008. Hence, the learned counsel

for the applicant submitted that respondents be directed to decide

the application dated 27.07.2010. Applicant is legal heir of deceased.

He was dependent of deceased. Therefore, the following order is

passed.

ORDER

1. The O.A. is partly allowed.

2. The respondents are directed to decide the application of the

applicant dated 27.07.2010 for appointment on compassionate

ground.

3. If the applicant is found eligible, his name is to be entered in

the waiting seniority list for appointment on compassionate ground.

4. No order as to costs.
