JUDGMENT

Heard Shri H.Dangre, learned counsel for the applicants in O.A.No.818/2019, Shri S.S.Ghate, counsel for the applicants in O.A.No.1026/2019 and Shri A.M.Khadatkar, learned P.O. for the Respondents. In both O.As. grievances of the applicants are common.
 They have prayed common relief. Therefore, both O.As. are decided by this Common Judgement.

3. During the course of submission, the learned counsel for the applicants Shri S.S.Ghate has filed copy of the G.R. dated 08.11.2023. It is marked Exhibit-X for identification.

4. Case of the applicants in short is as under-

The applicants in O.A.No.818/2019 were appointed in the year 2009 as per the Chart given below-

5. All applicants in this O.A. prayed to quash and set aside the communication dated 02.02.2019 by which there ad-hoc services were not taken into consideration for continuity in service. All the applicants have prayed that they should be treated as regular employee from the date of their initial appointment and all the benefits of pay fixation shall be given by taking into account of their service from the date of their initial appointment. Hence, all applicants approached to this Tribunal for the following reliefs*i*) Set aside and quash communication dated 02/02/2019 (Annx- 35) issued by the office of Secretary, Department of Medical Education And Drugs, Government of Maharashtra addressing to Director Medical Education And Research and Deans of all Medical Colleges thereby seeking to restrict continuity in the services of applicants right from the date of their initial appointments as granted by various judicial pronouncements, only for the purpose of annual increments and earned leave and depriving the applicants from revision of their pay scales as per Government Resolution dated 10/11/2009 (6th Pay Commission) i.e. revised Pay Band plus Academic Grade Pay *i.e. their services prior to 21/01/2009 (date of regularization of* service) will not be taken into consideration and for computing the benefits of annual increments and other benefits, their pay scales would be as per earlier 5th Pay Commission and not 6th Pay Commission;

ii) Direct the respondents to fix revised pay scale/Band alongwith Academic Grade Pay to applicants as per Government Resolution No. PAY-2009/C.R.181/09/Vaiseva-2, dated 10/11/2009 with respect to "revision of pay scales of Medical Education And Drugs Department-Teachers in Government Medical/ Dental and Ayurvedic Colleges" by treating them in continuous service with effect from their initial/first date of appointment and grant them all consequential benefits thereof along with interest and within stipulated period;

iii) Direct the respondents to compute and grant the annual increments and other consequential benefits to the applicants on the basis of revised pay scale fixed as above by treating their services as continuous with effect from the date of their initial / first appointment and as per judgment and order dated 05/04/2010 passed by Hon'ble Maharashtra Administrative Tribunal, Nagpur Bench, Nagpur in various Original Applications and subsequent order dated 16/08/2017 passed by Hon'ble High Court of Judicature At Bombay, Nagpur Bench, Nagpur in Writ Petition No. 5143/2010, alongwith interest and within stipulated period;

iv) Direct the respondents to pay difference / arrears of annual increments and other benefits to applicants by computing the same as per revised pay scale fixed as above alongwith interest and within stipulated period;

v) Allow the present application with cost on respondents;

vi) Grant any other relief or pass any other order, which this Hon'ble Tribunal deems fit and proper in the facts and circumstances of the matter.

Interim order/relief, if any, prayed for :-

The applicants reserve their right to claim interim order/relief at appropriate stage if so necessitated during the pendency of the present proceedings.

6. In O.A.No.1026/2019, the applicants have claimed that they were appointed in the year 2009 (pg.24). They were appointed as per the Chart given below-

7. Their grievances are that the respondents have communicated by communication dated 02.02.2019, stating that applicants are not entitled to get benefit of regular service from the date of their initial appointment. It is the contention of the applicant that they were appointed on a full vacancy by completing all the procedure. Hence, they are entitled for regularisation of their service from the date of initial appointment. They are entitled to get the benefit of pay fixation of 5th Pay and 6th Pay. Hence, all applicants approached to this Tribunal for the following reliefs-

i) By suitable order or direction be pleased to call for R & P in the matter of communication dated 02/02/2019 and upon perusal of the same be pleased to hold and declare that the communication dated 02/02/2019 at Annexure - 10 passed by respondent. No.1 is quashed and set aside. Further be pleased to hold and declare that the applicants are eligible for benefits when the applicants were and are on ad-hoc basis for the benefits of pay protection, yearly increment and earned leave;

ii) By allowing the application extend the benefits yearly increment, pay protection and earned leave till the period the applicants are regularized and the monetary benefits as per 4th Pay be extended within stipulated period together with interest @12%;

iii) Allow this application with costs;

iv) Grant any other or further relief as may be deemed fit and proper in the facts and circumstances of the present case.

INTERIM ORDER, IF ANY:

i) By an interim order during pendency and final disposal of the original application, stay the effect, operation and execution of the impugned communication dated 02/02/2019 and incidental recovery be stayed, in the interest of justice.

ii) Grant Ad - interim order in terms of Prayer Cl.10] i)

iii) By an further interim order direct the respondents to fix the pay of all the employees as per 7th Pay Commission by calculating the yearly increments earned by them during their service on Adhoc basis.

8. Both O.As. are strongly opposed by the respondents by filing their respective replies. It is the condition that applicants are

appointed temporary on ad-hoc basis. Therefore, their temporary service cannot be counted for the purpose of granting regular pay. Their services were not regularised from the date of their initial appointment. Hence, they are not entitled for the reliefs.

9. During the course of submission, the learned counsel for the applicants have pointed out the G.R. dated 08.11.2023. The material portion of the G.R. is reproduced below-

 तसेच विधि व न्याय विभागाच्या दि.२८.०२.२०१७ च्या परिपत्रकातील तत्व/निर्देश दि.०२.०२.२००९ रोजीच्या अधिसूचनेन्वये (सन २००९ व सन २०१० अशा दोन टप्प्यात) समावेशन झालेल्या उर्वरित वैद्यकीय अधिकारी, गट-अ (एस-२०) यांना लागू करण्यात येऊन त्याचे देखील नियमित पदावर केलेल्या अस्थायी सेवेच्या कालावधीतील तांत्रिक खंड अर्जित रजेमध्ये रुपांतरीत करुन सदर सेवा कालावधीतील अर्जित रजा व वार्षिक वेतनवाढी मंजूर करुन सदरचे वैद्यकीय अधिकारी समावेशनापूर्वी नियमित पदावर ज्या तारखेला अस्थायी स्वरुपात सेवेमध्ये प्रथमतः हजर झाले त्या तारखेपासून आजपावेतोची वेतननिश्चिती करण्यास सदर शासन निर्णयादवारे मान्यता देण्यात येत आहे.

10. The learned counsel for the applicants Shri H.Dangre has submitted that all applicants / Doctors were appointed by following due procedure. They were appointed on full vacancy. They were appointed on permanent post. Therefore, their services cannot be treated as ad-hoc services. The G.R. is very clear. The learned counsel for the applicant has submitted that as per this G.R., all benefits of pay fixation shall be given from the date of their initial appointment. Hence, at last submitted that the O.A. be allowed as prayed.

11. The G.R .dated 08.11.2023 is very clear. By this G.R. impugned communication dated 02.02.2019 is considered in the recent G.R. dated 08.11.2023. As per clause 3 of the G.R., all the Doctors who were appointed before 2009 shall be given all the benefits of pay fixation by treating their service as regular service from the date of their initial appointment.

12. In view of the G.R. dated 08.11.2023, the applicants are entitled to get all the benefits of pay fixation of 5th and 6th Pay Commissions by treating their services as regular services from the date of their initial appointment. Hence, the following order.

<u>ORDER</u>

1. The O.As. are allowed as prayed.

2. The impugned communication dated 02.02.2019 is hereby quash and set aside.

3. The respondents are directed to pay all the benefits to the applicants of 5th and 6th Pay Fixation and subsequent Pay Commission by treating their services as regular services from their initial date of appointment.

4. The respondents shall complete all these exercise for pay fixation etc. and pay all benefits to all applicants within a period of six months from the date of the receipt of this order.

5. No order as to costs.
