# ORAL ORDER (Delivered on 7<sup>th</sup> February, 2019)

1. Heard Shri Ravi R. Bangar learned Advocate for the applicants and Shri N. U. Yadav learned Presenting Officer for the respondents.

2. By the present application, applicants are claiming following reliefs:

"(A-1) By appropriate order or directions respondents may kindly be directed to hold and declare applicants are entitled to get exemption from passing professional examination in view of crossing of age of 45 years in view of the Government Resolution dated 01-11-1977 from their respective dates which are given at **"Exhibit A-2**" of Original Application.

(B) By appropriate order or directions the respondents are directed to grant the pay scale of Junior Engineer to the applicants on completion of 12 years continuous service by the respective applicants as per the Assured Progress Scheme with arrears of the salary, pay and allowances.

(C) By appropriate order or directions the order passed by respondents rejecting the claim of the some of the applicants of Assured Progress Scheme may kindly be quash and set aside and further declare that the applicants are entitle for the benefits of Assured Progress Scheme with arrears of the salary, pay and allowances."

3. Learned Advocate for the applicants files true copy of judgment delivered by this Tribunal in O.A.No.395/2015 on 17<sup>th</sup> March, 2018. It is taken on record and marked as document "X" for the purpose of identification. The decision would show that the Division Bench of the Hon'ble High Court has decided the issue in 2 cases as can be seen in paragraph 8 and 9 of the order.

4. Relying on the decision in the said judgment, this Tribunal had allowed the said O.A. As the present applicants have already reached the age of 45 years, they stood exempted from passing the professional examination as per rules. Therefore, they would become eligible for being considered for grant of time bound promotion and eventually grant time bound promotion in case they fit in the scheme and otherwise found fit for promotion.

5. In the circumstances, we pass following order:

#### <u>O R D E R</u>

- (i) The Original Application is disposed of without any order as to costs.
- (ii) The respondents are directed to consider all the applicants for grant of time bound promotion as well as assured career progression scheme by exempting them from passing of the professional examination as required under Rule 3 Sub Rule
  (a) of the 1998 Recruitment Rules for Junior Engineers on reaching 45 years' age, provided that the applicants meet all other criteria as per schemes of time bound promotion.
- (iii) The respondents are directed to consider the cases of the present applicants as directed above within a period of 4 months' from the date of

this order and the necessary orders shall be issued by them and the said orders shall be communicated to each of the applicants by Registered Post Acknowledgement Due, thereafter.
