ORAL ORDER [PER: VICE CHAIRMAN (A)]

This O.A. has been filed by the Applicant who has applied for one post reserved for VJ(A) category for the post of Smithy Instructor in the office of Additional Director General of Police and Inspector General of Prison Pune. Advertisement for the post was issued on 7th August, 2013.

2. Learned Advocate for the applicant stated that the applicant has applied for one post reserved for VJ(A) category though the applicant belongs to NT(B) category as the posts in DT-NT category are inter-transferable. However, reservation for the post was changed by the respondent no.1 and out of 3 posts for Smithy Instructor, one post was reserved for S.T. category and two posts were kept Open. The Applicant was considered from Open category and he could not come in the merit list. Post reserved for S.T. category was not filled and it was kept vacant.

- 3. Learned Advocate for the applicant prayed that the respondent no.1 be directed to give appointment to the applicant on ad-hoc basis against the post reserved for S.T. category, which has remained vacant. He contended that if a reserved post could not be filled and there is urgency of filling the same, the post could be filled on ah-hoc basis by a candidate from other category.
- 4. Learned P.O. has stated that the applicant was not found to be meritorious for selection on the post of Smithy Instructor from Open category. He could not be considered from DT NT category as reservation was changed and no post from DT-NT category was reserved. This O.A., is therefore, without any merit and the Tribunal may not interfere in the matter. As per the Maharashtra State Public Services Reservation for Schedules Castes, Scheduled Tribes, Denotified Tribes (Vimukta Jatis), Nomadic Tribes, Special Backward Category and other Backward Classes Act, 2001, the post reserved for a particular reservation category has to be carried forward for 5 years, if suitable candidate from that category is not available. Learned P.O. stated that whether the post is required to be filled on urgent basis

has to be decided by the respondent no.1 and Tribunal

may not interfere in such matters.

5. We are inclined to accept the above submissions

made by the learned P.O. It is unfortunate that

respondent no.1 changed reservation for the post of

Smithy Instructor and no post came to be reserved for

DT-NT category. However, there is no allegation and

challenge from the applicant against the decision taken

by the respondent no.1 changing reservation. It is an

admitted fact that the applicant could not make it on the

basis of his merit from Open category. The post reserved

for S.T category could not be filled. However, this

Tribunal is not inclined to give any direction to the

respondents to give appointment to anyone on ad-hoc

basis on that post. Accordingly this O.A. is dismissed

with no order as to costs.
