2. In this case the applicant appointed in service as Junior Clerk vide order dated 13/2/2013 and he was appointed and posted in the District Institute of Education and Training, Aurangabad. The applicant made representation to the respondents to transfer him at any station in Nagpur Division as his mother was suffering from illness. The request of the applicant was considered and vide order dated 11/12/2017 (Annex-A) the applicant was transferred on the establishment of Divisional Director, Nagpur on equivalent post. Thereafter order dated 16/12/2017 was passed and the applicant was posted on the establishment under the Dy. Director, Education Department, Nagpur. The third order dated 21/12/2017 was passed and the applicant was given posting. Accordingly, on 1/2/2018 the Dy. Director of Education, Nagpur Division passed the order and the applicant was appointed as Junior Clerk in the office of Pay-GPF, Nagpur and accordingly the applicant resumed duty on 2/2/2018.

3. It is grievance of the applicant that all of a sudden the Dy. Director, Commissionerate Education Office passed the order on 26/10/2018 and informed the applicant that his transfer from Aurangabad Division to Nagpur Division was cancelled.

4. In view of these circumstances, it seems that as per the earlier transfer order, the applicant was transferred from Aurangabad Division to Nagpur Division, he was posted in the Pay Unit and he resumed the duty on 2/2/2018. The applicant was not due for transfer, because as per the Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005 (In short "Transfers Act of 2005") his normal tenure was three years. It seems that before completion of the normal tenure without assigning any reason, his transfer is cancelled. In my opinion once transfer order was executed, there was no reason to cancel the order as it was executed, therefore, the subsequent order dated 26/10/2018 is in fact amounts to transfer of the applicant from Nagpur Division to Aurangabad Division and it is apparently in violation of Section 4 (4) & (5) of the Transfers Act, 2005. In order dated 26/10/2018 no reason is mentioned for issuing this order, I therefore, accept that the order dated 26/10/2018 is contrary to law and it cannot be sustained. Hence, the O.A. is allowed. The

order dated 26/10/2018 is hereby set aside. No
order as to costs.

No. 30) to amend relevant pay-scale of the applicant as per the provisions contained in G.R. dated 21/12/1998 (Annexure-A-3, P.B., Pg. No. 12). The respondent no. 4 i.e. Executive Engineer is directed to fix pay of the applicant as per the directions given by Superintending Engineer (Respondent no. 3) **within two months** from the date of this order.

3. With this direction, **O.A. is disposed of with no order as to costs.**
