2. We have perused the reply filed by the respondents on 11.04.2022 and para nos. 3 & 4 are more relevant. The first D.P.C. took place on 11.02.2021 and following reasons were assigned for not giving the promotion to the applicant. Second D.P.C. was taken place on 08.12.2021 and in this D.P.C.; previous points were mentioned but apart from that one point was added that applicant could not achieve the Benchmark of 20 points; on the basis of her grading of A.C.R., this was an additional point added in second D.P.C.. The second D.P.C. was conducted in compliance of M.A.T. order through circulation method which is mentioned in para no. 3. The third D.P.C. was conducted on 09.02.2022 which is mentioned in para no. 4 and again following points are mentioned in which it is also mentioned that applicant did not achieve Benchmark of getting 20 points, on the basis of grading of A.C.R.. In the last part of the 4th para; it is mentioned that D.E. was ordered against the applicant although completed but it has been kept in dormant file.

3. We fail to understand that when D.E. was ordered and completed then why it was kept in

Dormant file. The final order should have been issued; if there is any hurdle in passing final order; respondents should communicate to the Bench.

4. Ld. P.O. is directed to take instructions on this point only. As submitted by ld. counsel for the applicant, how benchmark was calculated of the applicant for the last five years of promotion; since applicant was under suspension and also facing D.E..So a chart should be given along with the affidavit that how benchmark have been calculated.
