2. The question involved is that from which date the second ACP should be paid. As per the Hon'ble High Court of Judicature at Bombay Judgment (Annex-A,P104) dated 6/2/2019 in Writ Petition No. 2605/2017 in case of **the Association of the Sub-Ordinate Service of Engineers (M.S.) & Ors. Vs. State of Maharashtra & Ors.** and in para-42 following order has been given -

“ (42) In this view of the matter, the denial of the second benefit under the MACP Scheme, with reference to an exercise of cadre restructuring and the revision in pay scale, in the year 1984, appears to be legally unsustainable. We are, thus, inclined to answer the aforesaid question in the 'negative'. We hold and declare that the up gradation under G.R. dated 16th April, 1984 does not constitute grant of non-functional pay-scale and cannot be treated as the 'first benefit' within the meaning of Clause 2 (b) (b) of the G.R. dated 1st April, 2010. We are, thus, inclined to allow the petition.”

3. In office note of the Assistant Chief Engineer, Irrigation Department, Nagpur dated 20/11/2019 (P-54 to 56) and on page no.55 details of applicant has been given in the table where the applicant was first appointed on 13/6/1982 and first ACP was granted from 1/10/1994. In column no.5, it is mentioned that after first ACP and 12 years, second ACP date comes as 1/10/2006. As per the Hon'ble High Court Judgment, the applicant's grievance is fully covered and the applicant is entitled for second ACP from 1/10/2006. As per the record, the Assistant Chief Engineer, Irrigation Department Nagpur again vide correspondence dated 3/6/2020 (A-19,P-79) in the last para had asked guidance from the Secretary, Irrigation Department, Mumbai regarding from which date the second time bound promotion is given. When already the Hon'ble High Court has interpreted that when it should be given and in his own office note dated 20/11/2019 (P-54 to 56) on page no.55 as per the Hon'ble High Court Judgment there is no need to ask the Government for guidance regarding second time bound promotion. The learned counsel for the applicant also pointed by the G.R. dated 1/7/2011 (P-50) and in point no.3 the Finance Department has clarified as follows –

(i) The applicant's second time bound promotion be granted from 1/10/2006 and accordingly pay fixation should be done as per discussion above.

(ii) As submitted by the learned counsel for the applicant this exercise has been done by the Department. The communication dated 3/6/2020 (A-19,P-69) is quashed and set aside. However all the arrears related to this fixation should be paid as per prayer clause no.16 (iii) of the O.A.
