2. The Civil Application for condonation of delay is filed with a prayer to condone the delay of 84 days.

3. From the perusal of prayer in the O.A., it is clear that the applicant has challenged the order of appointment of Police Patil issued by respondent no.2, dated 19/12/2015. As per the Rule 6 of the Maharashtra Village Police Act, 1967, the tenure of Police Patil is of five years. The appointment order challenged in the present O.A. is dated 19/12/2015. It appears that the period of five years is now over. Moreover, the applicant appeared in the examination and when he found unsuccessful, he approached to this Tribunal.

4. Heard Shri S.A. Sainis, Id. P.O. for respondent nos.1&2. He has pointed out the Judgment of Hon'ble Supreme Court in the Case **of Madras Institute of Development Studies and Ano. Vs. K. Sivasubramaniyan & Ors. with connected matter (2016) 2 SCC,454.**

5. As per the Judgment of Hon'ble Supreme Court in the case of **Madras Institute of Development Studies and Ano. Vs. K. Sivasubramaniyan & Ors.** (cited supra), when the candidate takes part in the examination process and when he found that he is unsuccessful and thereafter he challenges the appointment order of other candidates, then relief cannot be granted.

6. In view of the Judgment of Hon'ble Supreme Court in the case of **Madras Institute of Development Studies and Ano. Vs. K. Sivasubramaniyan & Ors.** (cited supra), the applicant is not entitled for relief. The reply filed by the respondents shows that the applicant appeared in the examination, he got less marks than the appointed candidate, i.e., respondent no.3. Hence, relief itself cannot be granted and delay cannot be condoned.
