2. It is pointed out that the applicant stood retired on superannuation on 30.06.2020 and order of proposed recovery (A-2) is passed on 06.05.2022. It is submitted that under the impugned order the respondent proposes to recover amount said to have been paid in excess since 01.11.1996. It is submitted that the applicant is not getting pension and pensionary benefits also have been withheld on account of proposed recovery. It is submitted that the applicant is praying for grant of interim relief as stated in para no. 11 (ii) of the application. Said prayer is as follows:-

“ii Direct the respondents, particularly the respondent no. 3 to release the pension and pensionary benefits of the applicant by withholding the impugned recovery (not consent for recovery) during the pendency of the instant O.A. and subject to outcome of the O.A. reserving right to claim interest on the said amount.”

3. Heard ld. P.O.. The aforequoted prayer deserves to be granted in view of facts of the case.

4. The respondents, particularly the respondent no. 3 shall release the pension and pensionary benefits of the applicant by withholding the amount of proposed recovery during the pendency of this O.A. and subject to outcome of the O.A..
