2. The applicant is challenging the action of the respondent no.2 in degrading ACRs. of the applicant from 'A+' to 'B+' during the year 2014-2015 and 2015-2016. I have perused the C.Rs. of the applicant written by the previous Officers and confirmed by even the Divisional Commissioner, Nagpur. On perusal of Annex-A-6, it seems that 'A' Grade was given to the applicant in the year 2014-2015 and 'B+' Grade was given in the year 2015-2016 by his Reporting Authority. The respondent no.2 disagreed with the remarks and for the year 2014-2015 he was brought down to 'B+' and for the year 2015-2016 he was brought down to 'B'. It is noticed by the Reviewing Authority i.e. the respondent no.2 that the work was not excellent, the employee was not efficient and his progress was partially good. It is also observed that the employee was not interested in the work, he was staying at

Nagpur for years together and he was morally tempted and he was bringing pressure on the higher authorities for cancellation of his transfer. The learned P.O. candidly submitted that there is no material to support these observations made by the Reviewing Authority.

3. No doubt, the Reviewing Authority is empowered to disagree with the remarks given by the Reporting Authority, provided for the disagreement, there must be cogent reason and material. In the present case, it seems that it is observed by the respondent no.2 in C.R. for the year 2015-2016 that the applicant was morally tainted, but this remark was written without supported by any material. It is not shown that when the applicant brought pressure on the higher authorities for cancellation of his transfer, even in the reply filed by the respondent no.2 in para-3, it is mentioned that the applicant was transferred to Gadchiroli, but the applicant tried hard and managed to obtain transfer to Nagpur. Thus, it seems that the respondent no.2 was biased, as the applicant was successful in cancellation of the transfer order. It is not cleared by the respondent no.2, who was the Authority to cancel the transfer order. Under these circumstances, even after reading the reply, it can be said that there was strong bias for bringing down

the gradation of the applicant. Attempt was made by the respondent no.2 to say that the Grade-B cannot be termed as 'adverse', but after reading the actual remark that the applicant was morally tainted government servant, it is not possible to accept that the remarks is not adverse. On the contrary, on the basis of such remarks, the DPC may refuse promotion. As it is demonstrated that the respondent no.2 reviewed the C.Rs. of the applicant for the year 2014-2015 and 2015-2016 and in absence of any material brought him down in gradation, therefore, I am compelled to say that this action of the respondent no.2 is in violation of the norms settled for writing the annual C.Rs., therefore, the O.A. is allowed and the C.Rs. written by the Reporting Authority are restored. No order as to costs.

2. The applicant stood retired from the service on 31.03.2012 on attaining superannuation. Accountant General, Nagpur sanctioned pension Rs. 9,175/- to the applicant and it was paid to the applicant till June, 2012. Later on criminal case was registered against the applicant as he was responsible for loss of the documents and consequently his pension was stopped and Accountant General, Nagpur passed the order to pay provisional pension to the applicant till Feb, 2019.

3. We have perused the letter dated 01/07/2019 written by District Superintendent of Land Record, Wardha. In this letter it is mentioned that after June, 2019 provisional pension is not paid to the applicant. It seems that the applicant has received the amount under G.I.S., G.P.F. and Commutation and as per this letter the applicant has not received the amount on account of leave encashment, gratuity and pension after June, 2019.

4. It is not disputed that the applicant is acquitted in the criminal case on 26/06/2018 and till today appeal is not preferred by the Government to challenge that acquittal. It is accepted by both the parties that till today chargesheet is also not served on the applicant. As per the direction of the Hon'ble Apex Court, the departmental enquiry must be completed at an outer limit within one year. In this case even after acquittal of the applicant no decision is taken by the Government to serve chargesheet on the applicant or to challenge his acquittal.

5. Under this circumstances, we allow the O.A., the respondents are directed to release the pension, gratuity and leave encashment amount to the applicant **within period of eight weeks** from the date of this order.

6. With the above directions, **the O.A. is allowed with no order as to costs.**
