The applicant appeared in the examination, but his result is not declared by the respondents on the ground that more wrong / identical answers were given by the applicant.

3. The learned counsel for applicant has pointed out the merit list of the candidates. It is filed today. It is taken on record and marked Exh-X for identification. As per his submission, some of the candidates obtained '0' mark even though they are shown in the result sheet of the examination, but name of applicant is not shown in the result sheet of the examination.

4. Heard learned CPO. As per his submission, the applicant has committed misconduct / unfair practice. The learned CPO has pointed out Clause no.14.4 of the advertisement. It is reproduced below –

“१४.४ विभाग उमेदवारांच्या वैयक्तिक प्रतिसादांचे (उत्तरे) विश्लेषण इतर उमेदवारांच्या प्रतिसादांशी अचूक आणि चुकीच्या उत्तरांच्या समानतेचे नमुने शोधण्यासाठी करेल. यासंदर्भात विभागाद्वारे अवलंबलेल्या विश्लेषणात्मक प्रक्रियेत, उमेदवारांनी उत्तरे एकमेकांसोबत वाटप (Share) केलेली आहेत आणि त्यांना मिळालेले गुण खरे / वैध नाहीत असा निष्कर्ष निघाल्यास विभाग अशा उमेदवाराची उमेदवारी रद्द करण्याचा अधिकार राखून ठेवते तसेच अशा उमेदवारांचे निकाल रोखले जातील.”

5. As per the condition mentioned in Clause no.14.4 of the advertisement that if there was any exchange of answers by the examinee and if any unfair practice was found, then his candidature will be cancelled.

6. Nothing is on record to show by the respondents that there was any exchange of answers etc. as mentioned in Clause no.14.4 of the advertisement. The applicant is

informed by the respondents that identical answers were given and therefore his answer sheet was not evaluated. This is not a proper reply by the respondents. Some of the candidates who obtained '0' mark, their names appeared in the result sheet. Without any evidence, it cannot be said that the applicant exchanged the answers sheet from two others or others examinees. Therefore, it cannot be said that the applicant has committed unfair practice in the examination. Hence, the following order –

(i) The respondents are directed to declare the result of applicant within a period of four weeks.

(ii) The appointment of other selected candidates will be subject to the outcome of this O.A.

7. Issue notice to respondents returnable **after four weeks**. Learned C.P.O. waives notice for State. Hamdast allowed.

8. Tribunal may take the case for final disposal at this stage and separate notice for final disposal shall not be issued.
