He submitted that as per the condition in the advertisement in Clause no.10.1 (i) that the applicants should have possessed Bachelor's and Master's Degree in the relevant branch with first class or equivalent in any one of the two degrees. The applicants have not possessed Bachelor's and Master's Degree in the relevant branch with first class and therefore they are not eligible to apply for the post of Lecturer / Assistant Professor.

The applicant nos. 2 and 3 are having 1<sup>st</sup> class in diploma and 2<sup>nd</sup> class in degree in the relevant branch and therefore the applicant nos.2 and 3 are eligible to apply for the said posts as per the advertisement in Clause no.10.1 (i).

8. The learned counsel for applicants has pointed out the recruitment rules as per clause (c) (iii) for the post of Professor in the department of arts and crafts, a degree or diploma of a certificate awarded by the Government in Arts and crafts. As per clause (c) (iv) for the post of the professor in the department of teachers training a degree in fine arts or applied art or applied art or a diploma in drawing and painting, sculpture and modeling, or applied art and art master certificate of diploma awarded by the Government.
