Advocate for the applicant seeks interim relief in the matter of admission to Post Graduate Course as an in service candidate subject to outcome of proposed Departmental Enquiry (DE) proceedings. He points out that applicant has appeared for NEET Examination 2021 dated 11.9.2021. The results of the examination were declared on 28.9.2021. The applicant has secured 315 marks and is therefore eligible to apply for the Post Graduation Admission Course. The cutoff marks for SC and Open Category is 265 and 302 respectively. The applicant has not been called for counseling on the ground that DE has been proposed and he is therefore not eligible as per clause 4.5 of GR dated 19.3.2019.
 - 3. He has further made an application dated 24.1.2022 to the Director of Health Services stating that he has not been given requisite marks as he has worked in Tribal/Difficult area. He has submitted an application to grant him additional marks at the rate of 10% each year and upto maximum of 30% of total marks which are to be given to any candidate who has worked in Naxalite/Tribal/Hilly/ Difficult area.

- 5. The learned P.O. has pointed out the Judgment in O.A. No.354/2020 dated 16.10.2020.
- 6. The applicant has already taken admission in P.G. course. As per order passed by M.A.T. Principal Bench, Mumbai in O.A.No.81/2022, following order is passed-

ORDER

The impugned order dated 08.12.2023 is hereby stayed till the filing of reply.

- 7. Issue notice to Respondents, returnable <u>after four weeks</u>. Learned P.O. waives notice for State. Hamdast allowed.
- 8. Tribunal may take the case for final disposal at this stage and separate notice for final disposal shall not be issued.
- 9. Applicant is authorized and directed to serve on Respondents intimation / notice of date of hearing duly authenticated by Registry, along with complete paper book of O.A. Respondent is put to notice that the case would be taken up for final disposal at the stage of admission hearing.
- 10. This intimation / notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules,1988, and the questions such as limitation and alternate remedy are kept open.
- 11. The service may be done by Hand delivery, speed post, courier and acknowledgement be obtained and produced along with affidavit of compliance in the Registry within one week. Applicant is directed to file Affidavit of compliance and notice.
- 12. In case notice is not collected within **three days** and if service report on affidavit is not filed **three days** before returnable date. Original Application shall stand dismissed without reference to Tribunal and papers be consigned to record.
- 13. **S.O. after four weeks**.
