2. By the impugned order dated 13.04.2023 (A-1) the order of transfer of the applicant dated 12.04.2023 (A-3) has been stayed. There is no

6. Be that as it may, except directions by the Hon'ble Chief Minister, nothing is in the file to know why the Government has suddenly stayed the transfer order dated 12.04.2023 in respect of the applicant. Once the applicant was transferred and posted and joined at Karveer, Dist. Kolhapur, there was no reason to stay the order and to undo all the exercise. Apart there is no approval of CSB. "

4. It is submitted by Id. C.P.O. that if stay is granted to the impugned order that would amount to granting final relief because the applicant would then join on his transferred post.

within one week. Applicant is directed to file Affidavit of compliance and notice.

7. In case notice is not collected within **three days** and if service report on affidavit is not filed **three days** before returnable date. Original Application shall stand dismissed without reference to Tribunal and papers be consigned to record.
