2. The Applicant prays that his candidature be considered for the post of Police Constable (Driver) as he is eligible and entitled in the category of VJ-A Category in the recruitment pursuant to Advertisement dated 06.11.2022 issued by the Superintendent of Police, Pune (Rural).

Thereafter, Applicant approached to Respondent No.3 forwarding representations dated 04.01.2024 & 03.04.2024 requested to consider his candidature on the vacant post of Police Constable (Driver) because no one from 'Select List' is willing to accept the appointment and last candidate who refused to join has secured same marks i.e. 136 marks as Applicant.

4. The office objection, if any, are to be removed and court fees to be paid, if not already paid.

5. Issue notice before admission returnable on 10.06.2024.
