 - b. any other and further order as this Hon'ble Tribunal may deem fit and proper in the interest of justice.

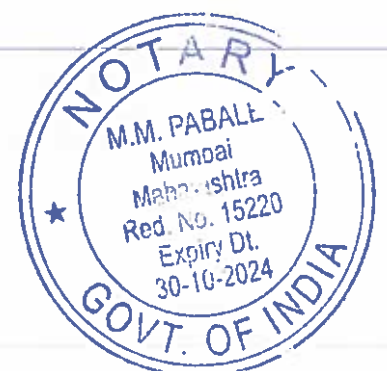

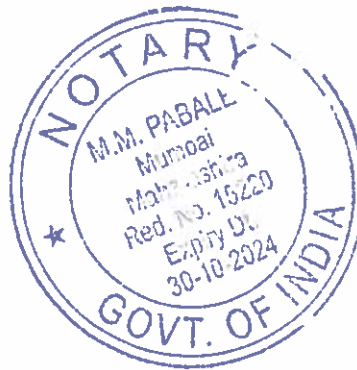

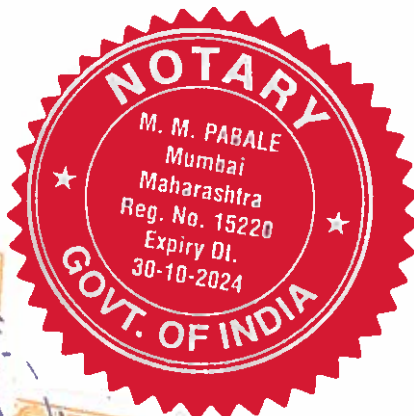
