RELIEF SOUGHT

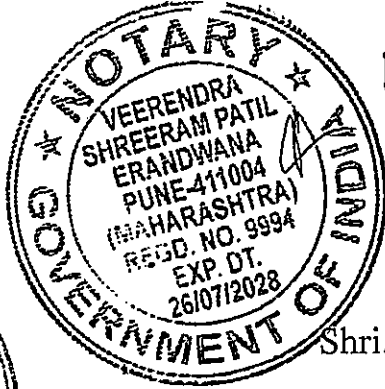
In view of the facts mentioned in paragraphs above Applicant prays for the following relief :

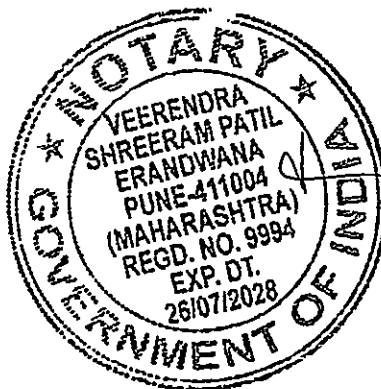
