1. The Applicants are challenging the validity of the Rule 10(1) Maharashtra Civil Service (Pension) Rules, 1982, as amended in the year 2022 dated 24.02.2022, to the extent of

the time limitation of its operation till 31.05.2023, thereby retiring the Applicants on 31.05.2023 and also due to the misinterpretation of the Government Resolution dated 29.08.2018. The copy of the Government Resolution dated 29.08.2018 is annexed to the Original Application. The Applicants are challenging the said action of the Respondents.

- 2. The present Original Application is filed seeking directions to Quash and set aside the amendment to the Maharashtra Civil Service (Pension) Rules, Rule 10 -dated 24.02.2022, to the extent of the time limitation of its operation till 31.05.2023.
- 3. The cause of action for the Applicants arises by the same Rule and the Government Resolution. Therefore the reliefs sought by all the Applicants are also similar. Hence, they have chosen to file a common O.A. to redress their grievances. Hence, the present Civil Application is filed to allow the Applicants to Sue Jointly.
- 4. Hence, the present Miscellaneous Application is filed to seek leave from the Hon'ble Tribunal to sue Jointly
- 5. The Applicants hereby declared that causes espoused in joint petition are essentially common and concurrent.

6. There is no slightest dissimilarity in claim of each of the Applicants.


