We note that as the Government itself has extended the period of wait list as per letter dated 10/03/2025 (Copy whereof is taken on record and marked as Exhibit –I), we are confident that the Respondents in the present O.A. will also adopt the same policy as Pune District and call the candidates by implementing the Circular, taking into account merit and also maintaining reservations.

7. With the above directions, as nothing remains in this matter. O.A. stands disposed of. If the applicant has any further grievance he has liberty to approach this Tribunal.

- (c) The applicant submitted a representation dated 24/03/2025 to Respondent No. 3, communicating the Hon'ble Tribunal's order dated 11/03/2025 and requesting compliance with the directions issued by the Hon'ble Tribunal. Copy of the representation dated 24/03/2025 is annexed and marked as 'Annexure C-2'.
- (d) The Respondent was served a contempt notice by hand to Respondent No.1 on16/04/2025, Respondent No.2 on 15/04/2025 and Respondent No.3 on 15/04/2025 as well as by mail on 15/04/2025 respectively. Copy of the contempt notice along with acknowledgements are collectively annexed and marked as 'Annexure C-3'.
- (e) The Applicant is compelled by the contemptuous act of the Respondents to file the Contempt Petition. Respondent have

willfully disobeyed the judgment and order of this Hon'ble Tribunal. As per the directions of this Hon'ble Tribunal the order was to be complied by Respondents, 1 month and 18 days elapsed, yet the order of Hon'ble Tribunal is not complied with. The Respondents have not called the Applicants other candidates eventhough the wait list has been extended by the letter dated 10/03/2025. There are at least 20-23 posts lying vacant.

Selection Committee has recently taken a decision to fill all the vacant posts in the Talathi Recruitment 2023 process by extending the waiting list, thereby providing an opportunity to the next eligible candidates based on merit. In light of this decision, the Applicant respectfully requests that the Nashik District Selection Committee showed follow a similar procedure and take appropriate action to fill all the 173 vacant Talathi posts in the Talathi Recruitment 2023 process.

The Applicant further submits that a representation has already been submitted to Respondent No. 3 on 03/03/2025 requesting the extension of the waiting list and filling of all the vacant posts of Talathi as per the advertisement.

Copy of the representation submitted to Respondent no. 3 on 03/03/2025 is annexed and marked as **Annexure C4.**

(g) The Applicant submits that strict action should be taken against the Respondent for deliberately disobeying and not complying with the judgment and order dated 11/03/2025 passed by this Hon'ble Tribunal in O.A. No.264 of 2025.

Hence this Contempt Petition.




