- 2. This is an application seeking condontion of delay of 6 years and 2 months caused for approaching to the court of law for redressal of grievance.
- 3. The applicant came to be retired by way of superannuation on 30.06.2016 from the post of Assistant Sub Inspector. It was followed by issuances of impugned order dated 13.10.2016 for recovery of excess payment to the tune of Rs.90,625/-. In pursuance of the said order, the amount has been recovered on 19.10.2016 from the retiral benefits.
- 4. It is the applicant's contention that the recovery made so far was against the law laid down by the Hon'ble Supreme Court in a case of <u>State of Punjab</u> and Ors. Vs. Rafiq Masih (White Washer) & Ors.

reported in (2015) 4 SCC 334. That is why he has invoked writ jurisprudence of Hon'ble High Court under Article 226 of Constitution of India.

- 5. Some facts are necessary to mention herein that initially for the said relief the applicant has filed Writ Petition bearing No. 687/2024, however due to existence of alternate efficacious remedy, the Hon'ble High Court remitted the matter to this Tribunal along with delay condonation application since the law of limitations applies to the Tribunal. The applicant has filed this application seeking condonation of delay of 6 years and 2 months caused in challenging the impugned order of recovery dated 13.10.2016.
- 6. The applicant has submitted that he is old age person and his wife is suffering from various ailments. Besides that due to medical problem and financial crisis, he was mentally disturbed that is why the delay occurred. He has also stated that recovery orders have been set aside in case of various similarly situated persons on which the applicant got knowledge and therefore, seeks to condone the delay.
- 7. Learned Presenting Office resisted this application by laying hand on the huge length of

delay which runs in to few years. It is submitted that the reasons stated in the application are not sustainable and thus the delay cannot be condoned.

- 8. The cause for approaching this Tribunal is for refund of the amount which was recovered by the respondents against the law laid down by the Hon'ble Supreme Court in a case of <u>State of Punjab and Ors. Vs. Rafiq Masih (White Washer) & Ors.</u>
- 9. Undisputedly the Hon'ble Supreme Court has rendered the said decision on 18.12.2014 and thereafter, the recovery has been made. While dealing this application, the said proposition of law is part of consideration. On the point of delay the applicant has stated the reason which I have already delineated. Though it is settled law that the delay shall be construed liberally, however, each case has to be decided on the basis of given facts. The applicant has come to the court though belatedly, but cause is to challenge the action which is against the law declared by the Hon'ble Supreme Court. Undisputedly, in similar situation, various orders have been passed by the Tribunal as well as the Hon'ble High Court basing on the said decision.

- 10. In above peculiar facts I have assessed the term "sufficient cause" which requires to be satisfied to the judicial mind. It is presumed that the delay is not intentional unless otherwise shown.
- 11. The other side has not shown any mala-fide and hence in absence of that in above peculiar facts, it is desirable to condone the delay. Having regard to the long length of delay, certain costs have to be imposed. In these circumstances, the following order is passed.

ORDER

- (a) The Misc. Application No. 113/2024 is hereby allowed.
- (b) The delay of 6 years and 2 months caused in approaching the Tribunal has been condoned on the condition that the applicant shall deposit costs of Rs.5,000/- (Five Thousand Only). The amount of costs shall be paid to the M.A.T. Bar Association within a period of two weeks from the date of this order.

- 3. Having regard to the limited prayer, the respondent Nos. 1 and 2 are hereby directed to take appropriate decision on the above referred representations within two months from the date of receipt of this order. All contentions raised in the present O.A. are kept open.
- 4. The Original Application is accordingly disposed of in above terms. No order as to costs.

- 2. By the present Misc. Application the applicant is seeking condonation of delay of 2 years, 9 months and 28 days caused in filing the Original Application to challenge the impugned order dated 07.02.2019, by which excess payment has been recovered. Thus the applicant's case stands on the decision of the Hon'ble Apex Court in a case of **State of Punjab and Others Vs. Rafiq Masih (White Washer) etc., (2015) 4 Supreme Court Cases 334.** So far as the delay is concerned, it is argued that the applicant is poor labourer, who was unaware about legal position, as well as financial constraints precluded from filing Original Application.
- 3. The State resisted this application by contending that the delay is huge running up to three years and thus, in absence of sufficient cause, it cannot be condoned.
