**O R A L - C O M M O N - O R D E R**

1. Heard Shri V.S. Kadam, learned counsel for the applicants in all these matters, Shri I.S. Thorat, learned Presenting Officer for the respondent authorities in all these matters, Shri G.N. Patil, learned counsel for respondent Nos. 2 & 3 in O.A. No. 238/2021, Shri S.B. Mene, learned counsel for respondent Nos. 2 & 3 in O.A. Nos. 239 & 240 both of 2021, Shri A.D. Gadekar, learned counsel for respondent Nos. 2 & 3 in O.A. No. 241/2021 and Shri N.U. Yadav, learned counsel for respondent Nos. 2 & 3 in O.A. Nos. 243, 244 & 254 all of 2021.

2. Since in all these matters issue involved is the proper implementation of G.R. dated 29.09.2003, I have heard all these matters together and I deem it appropriate to decide all these matters by this common order.

3. Majority facts are not in dispute. The applicants were initially daily wagers. Subsequently, they were brought on Converted Regulation Temporary Establishment (in short, CRTE) and in the passage of time, all were asked to work and have

actually worked on the higher post than the post on which they were shown to have been appointed. In the year 2003, the Government took a decision to ensure that each employee shall be given designation having regard to the duties and responsibilities being discharged by him and is paid wages commensurating to the said designation. The said scheme was popularly known as “कामानुसार हुद्दा व हुद्यानुसार वेतन”. It is the grievance of the applicants that though principally it was accepted by the department in which they have been working that all these employees have worked from 2003 onwards and even prior to that and have discharged the duties of the higher post though they were shown to be working on some different inferior posts. It is the case of the applicants that they have been given their appropriate designation and the appropriate pay scale of the said post from the year 2008 onwards, however, have not been paid difference of wages of the period from 29.09.2003. From the pleadings in the O.As., it reveals that in some matters, the applicants therein have been paid the wages according to their designation from the year 2008, in some of the cases the same have been paid from 2014 and in some matters from 2016. This information is consolidated in Annexure-A, appended to the present order.

4. During the course of arguments, it is revealed that the necessary information was forwarded by the office of Executive Engineer, under which the applicants are working to the office of Superintending Engineer and the office of Superintending Engineer has forwarded the said information for further necessary action to the Circle Office at Aurangabad. The main grievance of the applicants is that though the necessary information is consolidated and entitlement of the applicants has been crystalized by the office in which they are working, only because the proposals are not forwarded to the State Government by the said office, the applicants are deprived from benefits for which they are entitled.

5. The respondent Nos. 2 and 3 in all these matters have filed their joint affidavit in reply. Reply is filed in O.A. No. 238/2021 and it has been considered as reply in all other matters also, since the issues raised are similar in all these matters. Para No. 9 of the said affidavit in reply is material, wherein the respondents have stated that the information of arrears payable to the applicants according to their designation, which is given to them according to work they have been performing and pay scale according to that designation for the period 29.09.2003 to 16.11.2016 has been submitted vide office

letter No. N.I.C./Est-4/3472, Date-05.08.2021 to Superintending Engineer, Vigilance Unit, Aurangabad, as per the directive given by Govt. letter dated 28.02.2019.

6. The proposal as has been forwarded by the respondent Nos. 2 and 3 is admitted to the applicants.

7. Considering the facts as aforesaid, it appears to me that the actions are now required by respondent Nos. 4 and 1 i.e. State Government. In view of above, all these Original Applications deserve to be allowed by following order :-

**ORDER**

- (i) The respondent Nos. 1 and 4 are directed to decide the proposal received from the office of respondent Nos. 2 and 3 in respect of benefits to be given to the present applicants based on the G.R. dated 29.09.2003 and accordingly, pay the arrears as are worked out in the said proposal within 12 weeks from the date of uploading of this order on the official website of this Tribunal.
- (ii) All these Original Applications allowed in the aforesaid terms.
- (iii) There shall be no order as to costs.
