**JUDGMENT**

1. Heard Shri A.V. Bandiwadekar, learned Advocate for the Applicant and Shri A.J. Chougule, learned Presenting Officer for the Respondents.

2. The Applicant retired on superannuation on 30.04.2022 from the post of A.S.I. By the impugned letter dated 01.11.2022, he was asked to refund an amount of Rs.2,76,203/-. It was stated that said amount was paid in excess to him.

3 To his reply, Respondent No.3 has annexed letter of Pay Verification Unit dated 25.04.2024. As per this letter pay fixation of the Applicant was found to have been made correctly. Letter dated 05.08.2024 is also annexed to this reply which inter alia states -

4 Thus, it is apparent that there would neither be recovery from the Applicant nor would there be downgrading of his pay. The Original Application is accordingly disposed of with no order as to costs.
