JUDGMEN T

- 1. The present Misc Application is filed to recall the order dated 8.1.2025, whereby the Original Application No. 846/2024 was allowed to be withdrawn on the basis of the Pursis dated 8.1.2025, filed by the applicant. Learned counsel submits that Respondent No. 4, Shri R.B Kulkarni, is served through email and affidavit of service is filed.
- 2. Learned P.O on instructions from the office of the Registrar & Commissioner, Co-operative Societies, Pune, submitted that the applicant could not be given posting at Dombivli because criminal case filed by her against Shri R.B Kulkarni is pending before the J.M.F.C, Kalyan and also Labour Court.
- 3. Perused Exh. I in which the applicant has stated as follows:-

"मी केलेल्या अर्जाबाबत शासनाने सामंजस्याची भुमिका घेतलेली असून त्यावर माझे समाधान झालेले आहे त्यामूळे मी दाखल केलेली याचिका मुळ अर्ज क्र. ८४६/२०२४ हा मागे घेत आहे".

- 4. Learned counsel has referred to the application dated 9.1.2025, Exh. M-3, submitted by applicant to Respondent No. 3, informing that she has withdrawn the Original Application and she has requested that her transfer to Thane be cancelled and she be posted in the office of Assistant Registrar, Co-operative Societies, Ulhasnagar temporarily and her Establishment be kept in the office of Deputy Registrar, Co-operative Societies, Dombivli.
- 5. Perused the application at Exh. M-3. It shows noting of the office of Respondent No. 3, wherein remark is made on the said application that as per request made by the applicant the proposal is to be sent to the office of Respondent No. 2, Commissioner, Cooperative Societies.
- 6. Learned P.O pointed out that accordingly Respondent No. 3 sent proposal on 17.2.2025 to the office of Respondent No. 2, Registrar & Commissioner, Co-operative Societies and it was decided on 20.2.2025. She placed the said documents before us. The said document is taken on record and marked as Exh. I. This decision is taken by one Mr Deepak Taware, Commissioner, Co-operation and Registrar, M.S, Pune. The reasons given for transferring her again back to Dombivli is that the cases filed by her against one Mr Ram Kulkarni are pending in the Court of JMFC, Kalyan and also Labour Court. Therefore, it would not be appropriate to post her back to Dombivli and it is further mentioned that if at all request is made by her for transfer other than Dombivli, then the same will be considered.

7. Learned counsel has submitted that the applicant wants to

file representation giving option for transferring her to some other

places where posts are vacant other than Dombivli, which can be

considered by the Respondent-Authority. Learned counsel further

submitted that she will file representation today itself, i.e., on

25.2.2025. If such a representation is filed by the applicant, the

Respondents are directed to decide the same on or before

7.3.2025.

8. It is noted that the applicant did not join at Thane where she

was transferred and remained absent from duty since May 2024.

She is on medical leave after operation for Hysterectomy on

9.9.2024. As more than five months are over, the applicant is

directed to join her duty at Thane without prejudice on 27.2.2025.

9. With the above directions, Misc Application stands disposed

of.
